

THE SUBJECT SITS IN ONE OF TWO CHAIRS THAT ARE ROTATED DEPENDING UPON HIS COOPERATION. WHEN THE SUBJECT IS WILLING TO TALK AND IS MORE OR LESS COOPERATIVE A MORE COMFORTABLE CHAIR THAT IS PADDED, HAS ARM RESTS AND A MOVEABLE BACK IS BROUGHT INTO THE ROOM. WHEN THE SUBJECT IS LESS COOPERATIVE, A GRAY LAWN CHAIR IS BROUGHT INTO THE ROOM AND REPLACES THE MORE COMFORTABLE CHAIR.

4. ENTRY INTO THE INTERROGATION ROOM FROM THE LARGER BUILDING IS THROUGH A TWO DOOR VESTIBULE THAT IS APPROXIMATELY 3 FEET IN DEPTH FOLLOWED BY TWO OTHER DOORS THAT OPEN INTO THE INTERROGATION ROOM. THE BUILDING HAS TWO ROOMS ON THE FIRST FLOOR THAT ARE USED AS OBSERVATION ROOMS. ONE ROOM IS USED FOR THE INTERROGATION ROOM AND HAS THREE MONITORS AND THREE VIDEO TAPE MACHINES. THE SECOND ROOM IS USED BY THE SECURITY OFFICERS AND HAS ONE MONITOR CAPABLE OF SWITCHING CAMERA VIEWS. THE HALLWAY, WHICH IS RATHER WIDE AND LONG IS USED AS THE MEDICAL SUPPLY AND MEDICAL PREPARATION ROOM WHERE THE MEDICAL CREW HAVE ORGANIZED INTO A MINI-CLINIC FORMAT THAT COULD BE USED IN CASE THE SUBJECT HAS SOME SERIOUS MEDICAL CONDITION THAT REQUIRES IMMEDIATE ATTENTION.

5. THE UPSTAIRS HAS ONE LARGE ROOM THAT HAS BEEN DIVIDED BY TEMPORARY MOVEABLE WALLS INTO 6 DIFFERENT SUB-OFFICES THAT EACH TEAM, INCLUDING COMMO, USES AS THEIR STAGING EFFORTS.

6. SECURITY:

THE SECURITY OFFICERS HAVE ALL BLACK UNIFORMS, INCLUDING BOOTS, GLOVES, BALACLAVAS AND GOGGLES TO KEEP THE SUBJECT FROM IDENTIFYING THE SECURITY OFFICERS AS WELL AS KEEPING THE SUBJECT FROM SEEING THE SECURITY OFFICERS AS INDIVIDUALS WHO HE MAY ATTEMPT TO ESTABLISH A RELATIONSHIP OR DIALOGUE WITH. THE OFFICERS HAVE DEVELOPED HAND SIGNALS TO COMMUNICATE WITH EACH OTHER WHEN THEY ARE IN THE CELL OR THE INTERROGATION ROOM.

7. SECURITY HAS USED HAND-CUFFS AND LEG SHACKLES TO MAINTAIN CONTROL OVER THE SUBJECT AS WELL AS THREE LOCKS ON THE CELL DOOR
