 THE TOTAL CAPACITY OF ALL US-CONTROLLED FACILITIES AS OF 18 AUGUST WAS 6,460. BY DECEMBER, THE GOAL IS TO INCREASE CAPACITY TO 8500.

• THERE ARE ALSO SEVERAL SMALLER FACILITIES THAT ARE PRIMARILY IRAQI-RUN, BUT WITH US OVERSIGHT. THESE FACILITIES HAVE A TOTAL CAPACITY OF 2425 AND MOST DETAINEES ARE BEING HELD FOR IRAQI ON IRAQI CRIMES. THE US HAS A THREE-WEEK TRAINING PROGRAM IN PLACE TO HELP TRANSITION ALL OF THESE LOCATIONS TO FULL IRAQI CONTROL. THE NEW PRISON WORKERS ARE TRAINED WITH A FOCUS ON PRESERVING HUMAN RIGHTS AND FIGHTING CORRUPTION. THERE IS CURRENTLY A HIGH-ATTRITION RATE AND ONLY ONE FEMALE HAS GRADUATED. THIS IS MAINLY DUE TO THE STILL-SUBPAR LIVING AND WORKING CONDITIONS AT THE FACILITIES.

FUTURE PLANS:

- SHUT DOWN CAMP CROPPER EXCEPT HVD FACILITY. MAKE THE NEW ABU GHARYB FACILITY THE PRISON AND INTERROGATION HUB FOR BAGHDAD.
- INCREASE CAPACITY OF ALL IRAQI FACILITIES TO 17,160.

MAJOR CONCERNS:

- CPS STAFFING AND FUNDING OF PRISONS. A LOT OF MONEY IS EARMARKED FOR IRAQI USE, AND THE CPA CANNOT TOUCH IT.
- STAND UP AN IRAQI CORRECTIONS ADMINISTRATION.
- NO LONG-TERM MAINTENANCE PLAN FOR THE DETENTION FACILITIES EXISTS.
- THERE IS NO "LIFE SUPPORT" PLAN FOR DETAINEES, INCLUDING BASIC NEEDS LIKE HYGIENE, CLOTHING, ETC.
