

(TS/[]-NF) Capability: CTC, with the assistance of the Office of Medical Services, Office of Security, Office of Technical Service, and various Mission Support Offices employs a highly talented team that is currently interrogating a senior Al-Qa'ida terrorist, Abu Zubaydah; Zubaydah is employing refined counter-interrogation techniques. CTC's team is implementing SERE based individualized psychological pressures to counter Zubaydah's resistance, with some success, to obtain the actionable intelligence from him - including information that led to the arrest of Jose Padilla. []

[] The resources dedicated to this task are substantial and include the following:

- a. [] interrogators;
- b. [] SERE Psychologists;
- c. [] analysts;
- d. Medical Team (varied from a complete surgical team to [] medical doctor, [] physician's assistant, and [] nurse);

- g. Numerous other support officers at Hqs, station, and at the interrogation facility.




