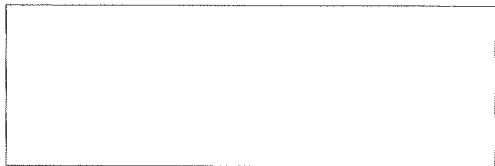

SUBJECT: (S/[REDACTED]) Death of Detainees

1. (S/[REDACTED]) On 4 November 2003, Manadal al-Jamaidi, a former Iraqi military officer, was captured by the US Military in [REDACTED] Iraq, during an early morning raid. US military and intelligence officials believed al-Jamaidi was involved in anti-coalition activities. [REDACTED]

[REDACTED] During the debriefing at [REDACTED] on 4 November shortly after he arrived there, al-Jamaidi slumped over. [REDACTED] summoned the military police who, in turn, summoned a military physician who determined that al-Jamaidi had died. [REDACTED] advised the Office of Inspector General (OIG) of this matter, and the OIG is investigating the death in conjunction with the US Army (CID).

2. (S/[REDACTED]) The CIA's OIG is also conducting an investigation with CID in connection with the death of Iraqi General Avid Hamad Mahawish Al-Malalawi, who died in military custody in northern Iraq on 26 November, [REDACTED]

[REDACTED] CIA will keep the Committees informed of these matters.
