- Interviews of Key Witnesses and Targets
- Document Collection and Review
- Coordination of Exhumations and Forensics at Mass Graves
- Selection of Small Group of Offenses and Defendants
- · Advising and Training of Iraqi Counterparts
- Liaison to International Community & NGOs

- 3/23 –3/25/04: RCAO Training in D.C.
- End of March: RCAO Deployment Begins
- Spring 2004: Selection of IST Judges & Staffing of Court
- Spring 2004: Adoption of IST Court Rules

## Timing (Continued)

- Summer 2004: Establishment of IST Court Building & Administration
- Fall 2004: First Indictment
- End of 2004: First IST Trial Begins
- End of 2004/Early 2005: Phase-Out of RCAO

### Funding

- RCA to have budget authority within CPA over \$75 million fund appropriated for IST assistance
- RCA and other non-DOJ personnel to be hired by CPA and detailed to RCAO
- RCA may retain contract support and expert consultants as necessary

- RCAO functions as DOJ component within Coalition Provisional Authority
- RCA reports to CPA Administrator
- Attorney General directs RCA regarding substantive legal and investigative matters
- After transfer of sovereignty, all CPA responsibilities will devolve upon State Department's Chief of Mission



# Commitments from Other Agencies: Defense Department

- Through CPA, support and sustain RCAO personnel in Iraq, including housing, food, medical, transportation, communications, security
- Provide access to relevant documents and declassification assistance
- Provide access to and transport of prisoners







- Under RCA, lead assistance in establishing IST infrastructure and court facility and in expedited selection of IST judges
- Recruit international investigative and forensic teams

- Iraq Survey Group will make available relevant documents and facilitate declassification
- Supplemental security, communications, and transportation support
