This is an Operation Iraqi Freedom Investigation.

This office was notified by $SSG^{(b)(6),(b)(7)(C)}$ Patient Administration Division, 31st Combat Support Hospital (CSH), Camp Cropper, IZ APO AE 09342 (CCIZ), of the death of Mr IBRAHIM while treated in the Intensive Care Unit (ICU), 31st CSH, CCIZ.

Investigation determined Mr IBRAHIM was admitted to the 31st CSH on 10 Feb 08 unresponsive, hypothermic and in a state of cardiac arrest. Multiple blunt force injuries were noted to Mr IBRHIM during his initial medical screening. The injuries were explained as suffered from an altercation with the Sons of Iraq while emplacing an Improvised Explosive Device, prior to his capture by Coalition Forces. Mr IBRAHIM was treated until 17 Feb 08. when he went into a state of cardiac arrest. Mr IBRAHIM did not recover from cardiac arrest despite lifesaving measures. Mr IBRAHIM was pronounced dead at 1043, 17 Feb 08. An autopsy conducted by the Office of the Armed Forces Medical Examiner (OAFME) revealed the cause of death was complications of blunt force injuries and the cause of death was homicide. The results of this investigation were consistent with their findings.

On 10 Jun 08, this investigation was referred to the Law and Order Task Force, FOB Shield, Baghdad, Iraq.
