RESULTS OF INTERVIEW OF (b)(6),(b)(7)(C)

1. On 04Jan07, at approximately 1250, Reporting Agent (RA) interviewed (b)(6),(b)(7)(C) JSMC, pertaining to his knowledge of the death of V/ABDAL. (b)(6), reported that on the afternoon of the incident, he was directed by one of the HUMINT Exploitation Team (HET) members (NFI) to get detainee number (b)(6),(b)(7)(stated he went to the detention center and told two (2) individuals at the Sergeant of the Guard (SOG) desk (NFI) to get the detainee and they brought him out.

2(b)(6). (informed RA that he took the detainee to the doctor's office for a 'before interrogation' medical screen that lasted for about 2-3 minutes. (b)(6) said the medical screen consisted of a visual screen that was conducted by(b)(6),(b) and no medication was given to V/ABDAL to the best of his knowledge. (b) stated he cuffed and (b)(7)(E) V/ABDAL and escorted him to interrogation box 4. (b)(6) said they arrived at box 4 without incident at which time he handed V/ABDAL over to the same HET guy. (b)(stated in his opinion V/ABDAL seemed fine and did not appear ill. (b)(6) reported V/ABDAL seemed elderly so he took his time walking him to box 4.

3. (b)(6), informed RA that after he had delivered V/ABDAL to box 4 he returned to the SOG area to "hang out". About 30 min later, (b)(6), heard someone yell for a corpsmen and (b)(6), left the area. Approximately 3-4 minutes after (b)(left the area (b)) saw someone doing compressions from the camera located in box 4. No further information was obtained.

RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 03Jan07, Reporting Agent (RA) responded to the Al Asad Surgical Hospital, Al Asad Air Base, Iraq, regarding a detainee (V/ABDAL), of from the Regional Detention Facility (RDF), who was brought into the hospital unconscious and unresponsive with Cardiopulmonary Resuscitation (CPR) in progress. Upon arrival at the hospital RA was advised V/ABDAL had died. Subsequently, RA interviewed (b)(6),(b)(7)(C) b)(6),(b) regarding his knowledge of V/ABDAL's death.

3 (b)(6).(b) related he observed the detainee lying on his back with his arms to the side, head towards the door and CPR in progress. (b)(6),(b) reported he recalled (b)(6),(b)(7)(grabbing the Oxygen bottle and at one point he (b)(6),(b)(went back to the RDF to retrieve the defibrillator (b)(6) (b)(stated he believed someone (NFI) said they felt a pulse (on the detainee) (b)(6),(b) indicated the pliers and wire cutters in the booth were used to try an open the oxygen tank. (b)(6),(b) related that (b)(6),(b)(7)(and (b)(6),(b)(could not get the defibrillator pads to stick on the detainee's chest because he was hairy (b)(6),(b) advised the people performing CPR were (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C) reported the fire department showed up and tried to figure out when the ambulance would be arriving (b)(6),(b)(stated they moved the detainee onto a stretcher and into the HMMMV and then left for to the hospital (b)(6),(b) provided a drawing of booth four as he remembered it from 03Jan07, enclosure (A) pertains.


