RESULTS OF INTERVIEW WITH (b)(6),(b)(

- 1. On 26Sep06, an interview was conducted witl(b)(6),(b)(7)(C)
 (b)(6),(b)(7)(C)
 USMC, a rifleman assigned on post at the detainee collection center, who witnessed the death of V/AHMED. The interview was conducted in the VIP room, Echo Company 2nd Battalion, 3rd Marines (2/3) Forward Operating Base (FOB), 2nd Battalion, 3rd Marines, Haditha, Iraq.
- 2. According to (b)(6).(b) he was on his off time when a Non-Commissioned Officer (NFI) told him that he was to stand watch at the detainee collection center, around 1200 on 24Sep06. (b)(6).(stated he noticed there was blood on V/AHMED's clothes, around his left knee, and little cuts and scrapes on V/AHMED's lower legs. (b)(6),(b) could not recall whether V/AHMED had any other markings on his face or head area.
- 3 (b)(6),(b) stated that he and (b)(6),(b)(7)(C) the other Marine on watch at the detainee collection center (NFI), would check on V/AHMED and at some point (time unknown) observed V/AHMED lying on the ground. (b)(6),(b) stated he and (b)(6), checked V/AHMED and noticed V/AHMED had a low pulse and was not breathing. (h)(6) (h) stated he went to retrieve a Corpsman, (h)(6) (h)(7)(C), and he and tempted to perform Cardio Pulmonary Resuscitation (CPR) on V/AHMED. (b)(6),(b) stated that at one point he and (b)(6),(b)(7) pulled V/AHMED on his side and noticed 2-3 large bruises on his back.
- 4. (b)(6),(b) stated that the senior Corpsman(b)(6),(b)(7)(C) arrived shortly after he and (b)(6),(b)(f) started CPR and assisted.
 (b)(6),(f) advise(b)(6),(b)(7) and (b)(6),(b) continued CPR on V/AHMED for approximately 15-20 minutes, befor (b)(6),(b)(7)(f) nd(b)(6),(b) ceased attempts to further conduct CPR on V/AHMED due to his death.

RESULTS OF INTERVIEW WITH (b)(6),(b)

On 26Sep06. an interview was conducted with (b)(6),(b)(7)(C) (b)(6),(b)(7)(C)USMC regarding his knowledge of V/AHMED's death. (b)(6),(b)(as posted at the detainee collection center with (b)(6),(b)(7)(during the death of V/AHMED. The interview was conducted in the VIP room, Echo Company 2nd Battalion, 3rd Marines (2/3) Forward Operating Base (FOB), Haditha, Iraq.

2. According to (b)(6)(b) he was placed on post with (b)(6)(b)(7)(C) to relieve (b)(6)(b)(7)(C) nd (b)(6)(b)(7)(C) because a detainee was being abused by Iraqi Police (IP). (b)(6)(b) stated he watched the three detainees for an unknown period of time, and noticed V/AHMED moaning. (b)(6) (b) stated he saw blood on V/AHMED's pants around his knees, and some blood on his face. (b)(6) (stated while V/AHMED was moaning, V/AHMED was talking to the other detainees.(b)(6),(b) stated V/AHMED moved around his cell a little. (b)(6), recalled tha (b)(6), (b)(6)told him to get a Corpsman, after (b)(6) (saw V/AHMED was lying on the ground in his cell (b)(6)(b)(stated that because the Quick Reaction Force (QRF) was being utilized he could not go anywhere for approximately five minutes due incoming fire from outside the FOB. (b)(6),(b) related after the ORF (b)(6),(b) told him that V/AHMED did not have a pulse, and he, (b)(6).(b) went to retrieve a Corpsman.

3. (b)(6),(b)(tated he me((b)(6),(b)(7)(C) and brought him to where V/AHMED was. (b)(6),(b) stated he did not stay long, a(b)(6),(b)(7) told to go get(b)(6),(b)(7)(C) (b)(6),(b) stated he also brought (b)(6).(b) stated he also brought to where V/AHMED and (b)(6),(b) were. (b)(6),(b) stated (b)(6),(b)(7)and (b)(6),(b) reformed CPR for approximately 15-20 minutes until (b)(6),(b) made the call that V/AHMED was dead. (h)(6) (h) stated he was told to get a body bag. (b)(6),(b) stated when he helped lift V/AHMED's remains in the body bag, he noticed multiple bruising on V/AHMED's backside, which (b)(6) stated was where the blood settled. (b)(6), (b) stated that (b)(6).(b)(an(b)(6).(b) took V/AHMED away in the body bag.

4.(b)(6).(b)(b)(b) drew a sketch of where V/AHMED was relative to the four detainee cells, enclosure (A) pertains.
