- 2. The first form of identification was an identification card for the Northern Oil Company Tribal Security under the alias for V/AHMED, Ismail Neama AHMED. The identification card is designated for V/AHMED's employment as a guard for the Haifa Pipe Line. The identification card lists his weapon serial number as 5324 Machine Gun (NFI).
- 3. The second form of identification seized from V/AHMED was a Iraq Republic - Ministry of Electricity General Administration for Defending on Electrical Power Systematic under the Company name ALSAKIR ALASHHAB For Security and Protection. The identification form listed V/AHMED as a guard, under his alias Hmood Mihedey JABER, and an issue date of 10May05, with a weapon registered as an AK-47, serial number 27011925.
- 4. The final form of identification is an Iraqi government identification card, which lists V/AHMED's name, DOB of 01Jul70, and POB as Hadithah, Iraq.
