As background, on 24Sep06, V/AHMED was found deceased in his holding cell in Echo Company, 2nd Battalion, 3rd Marines (2/3) Forward Operating Base (FOB), Haditha, Iraq several hours after being interrogated by Iraqi Police. According to the Death Certificate, the condition directly leading to V/AHMED's death is a penetrating wound to V/AHMED's left shoulder/chest.
