INTERVIEW OF (b)(6),(b)(7)(C)

On 06JAN06, Reporting Agent interviewed Al Asad's detainee number (b)(2),(b)(6),(b)(7)(C) and detainee number (b)(2),(b)(6),(b)(7)(C) at Al Asad Air Station IZ detention center. They were (b)(6),(b)(7)(C) (b)(6),(b)(7) who died while under detention by 2d Force Recon Company from their residence in Ar Rutbah to Forward Operation Base (FOB) Camp Korean Village on 04JAN06.

They were both interviewed separately and "Raj", an L-3 Corporation employee translated the conversation. (b)(6),(b)(7)(C) stated he was born in (b)(6), but he did not know the month or day. (b)(6),(7)(C) stated he was born in (b)(6), but he did not know the month or day either.

They knew that (b)(6),(b)(7)(C) had been born sometime in 1951, however, they did not know the month or day. They appeared to be unaware that (b)(6),(b)(7)(C) had died during transportation from their residence to Camp Korean Village and Reporting Agent did not tell them that fact.

Reporting Agent asked both of them if they were (b)(7)(E) and bound when they were first detained. They both responded yes and stipulated that (b)(7)(E) and that their wrists were tied behind their backs.

Reporting Agent in so many words asked if they were beaten by the Marines who initially detained them and drove them from their residence. They both responded no. (b)(6),(b)(7)(C) stated while he was in the vehicle someone stepped lightly on his chest once. (b)(6),(7)(C) stated he received two soft pats to the stomach while sitting in the vehicle.

They both stated that they did not have a conversation with anyone in the vehicle and they did not hear any commotion while in the vehicle. Reporting Agent then asked if they were provided a blanket while riding in the vehicle. (b)(6),(b)(7)(C) responded no and (b)(6),(7)(C) said yes, but the blanket had fallen to his feet while riding in the vehicle.

Reporting Agent asked if they were cold during transportation from their home and they both responded yes.

Reporting Agent then asked them if there was any medical condition that (b)(6),(b)(7)(C) had. They both responded no. No further questions were asked of them.
