EXAMINATION OF INTERROGATION ROOM REGARDING V/JABAR

1. On 19Feb08, Reporting Agent (RA) received information from NCIS Special Agent (SA) $(b)(6), (b)(7)(C)$ Joint Prosecution and Exploitation Center (JPEC), that a detainee, later identified as V/JABAR, from the Camp Al Asad Regional Detention Facility (RDF) had passed out during an interrogation. SA $(b)(6), (b)(7)$ advised that V/JABAR was still alive and was in the process of being transported to the Camp Al Asad Combat Support Hospital (CSH).
2. RA responded to the CSH and ascertained that V/JABAR was still alive but in critical condition. RA made contact with $(b)(6)$, $(b)(7)(C)$, USN, at the CSH, who advised that he worked at the RDF and had been treating V/JABAR at the RDF for the past eight or nine days. $(b)(6)$, $(b)(7)($ said V/JABAR had not been consuming enough food and water while staying at the RDF.
3. RA responded to the RDF and made contact with $(b)(6), (b)(7)(C)$ RDF Officer-in-Charge $(b)(6), (b)(7)(C)$ advised that he would provide RA with a copy of the video of the interrogation of V/JABAR, which is documented via separate correspondence. At approximately 1804 hours $(b)(6), (b)(7)(C)$ escorted RA to the interrogation room where V/JABAR was located prior to being transported to the CSH. The interrogation room is described as a conex box approximately 18 feet long and approximately 7 feet wide. The interrogation room contained one table and three gray folding chairs. Numerous items of medical equipment were still in the interrogation room. These items were used to treat V/JABAR prior to him being transported to the CSH. RA took photographs of the interrogation room and are appended to this document as Enclosure (A). Enclosure (B) is a sketch of the interrogation room.
4. No items were seized as evidence.
