NARRATIVE

- This reactive investigation was initiated to determine the events surrounding the death of V/JABAR. No criminal statutes apply at this time.
- 2. On 19FEB08, at approximately 1645 hours, NCIS was notified by NCIS Joint Prosecution Exploitation Cell (JPEC) Special Agents that a Camp Al Asad, Iraq, Regional Detention Facility (RDF) Detainee, V/JABAR, was en route to the 325th Combat Support Hospital (CSH), Camp Al Asad, Iraq after passing out during an interrogation. V/JABAR was transported to the 325th CSH, where he received emergency medical treatment, but died while in the Intensive Care Unit (ICU) on 20FEB08. Before his death, it was noted V/JABAR had not been eating or drinking sufficient amounts, and due to this, V/JABAR had been under the care of a USN Corpsman since his detainment. Additionally, V/JABAR had been medically cleared before his interrogation.
- 3. NCIS conducted a scene examination on 19Feb08. After his death on 20Feb08, V/JABAR'S body was transported to the Al Asad Personnel Retrieval and Processing (PRP) Detachment office for processing. On 22Feb08, V/JABAR'S body was transported to Dover Air Force Base, Dover, DE for an autopsy. This investigation continues.

ACTION

R. DCWA: Attend V/JABAR's autopsy and provide preliminary and final autopsy findings, as well as photographic coverage.
