## NARRATIVE

1. Reference (a) was received tasking NCISHQ 23B12 with tracking and providing MEBJ with autopsy and toxicology reports from the Armed Forces Institute of Pathology (AFIP) regarding post mortem examinations of V/NAHAR. A Certificate of Death (Overseas) was provided by AFIP and forwarded via Reference (b). The Final Autopsy Examination Report was received from AFIP indicating V/NAHAR's cause of death was Acute Peritonitis due to a perforating gastric ulcer. manner of death was listed as natural. The toxicology report was received indicating V/NAHAR's urine and liver were negative for drugs and/or alcohol. Exhibits (1) and (2) provide amplifying details. Exhibits (1) and (2) were forwarded to SA (b)(6),(b)(7)(C) in Al Asad Iraq, and SA (b)(6),(b)(7) Forensic Consultant, FEYK via electronic mail, therefore a mail copy will not be submitted. ## NARRATIVE

1. This investigation was initiated to determine the circumstances and cause of V/NAHAR's death in accordance with SECNAVINST 5520.3B.

2. V/NAHAR was apprehended on 01Oct04, for suspicious activities near a Syrian border check point. During in-processing into the detention facility at Camp Al Qaim, IZ, he was diagnosed with stomach ulcers by medical staff. At 1250 on 02Oct04, V/NAHAR was found unresponsive on the floor of his detainee cell by a guard. V/NAHAR was subsequently pronounced dead by medical personnel at 1308, 02Oct04. An autopsy will be performed in the Baghdad area by personnel from the Armed Forces Medical Examiner's Office.
