RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 26Sep06, Reporting Agent and Special Agent (b)(6),(b)(7)(C) met with (b)(6),(b)(7)(C) at the USMC Detention Facility at the 2nd Battalion, 3rd Marines (2/3) Headquarters, Haditha Dam. (b)(6),(b)(7)(C) was detained by USMC personnel and Iraqi Police (IP) in the city of Hadithah, Iraq for possible participation in the kidnapping and killing of Iraqi Police. (b)(6),(b)(7)(C) was interviewed regarding his knowledge of the death of V/AHMED. (b)(6),(b)(7)(C) as initially detained at the Forward Operation Base (FOB), Hadithah, Iraq before being transported to the Haditha Dam Detention Facility, Haditha, Iraq, on 26Sep06. Also present during the interview was (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) Civilian, a Titan Linguist Group Translator, who interpreted for (b)(6),(b)(7)(C) due to (b)(6),(b)(7)(C)'s inability to speak and understand English, and only speaks and understand Arabic.

2. (b)(6),(b)(7)(C) related he was in a cell with his brother (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) after being detained by American Forces. (b)(6),(b)(7)(C) related the IP's (NFI) later brought somebody named Hashum (V/AHMED) and placed him in the same cell as (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C) after V/AHMED was beaten by the IP's. (b)(6),(b)(7)(C) related V/AHMED was in pain, was moaning and vomited. (b)(6),(b)(7)(C) related V/AHMED was lying on the cell floor with him and (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) related that an American Doctor (NFI) came in the cell and moved V/AHMED's (b)(7)(E) (b)(6),(b)(7)(C) related he could see that V/AHMED had been beaten from head to toe. (b)(6),(b)(7)(C) related the American Doctor who came in the cell was nice, and the American Doctor gave V/AHMED water and medicine. (b)(7)(C) advised that the American Doctor also examined V/AHMED. (b)(6),(b)(7)(C) stated that V/AHMED could not talk because he was in too much pain. (b)(6),(b)(7)(C) related that V/AHMED had blood on his clothes and there was blood on the mattress V/AHMED was lying on. (b)(6),(b)(7)(C) advised that V/AHMED had had bruising and swelling all over his body. (b)(6),(b)(7)(C) related that V/AHMED did state that the head Iraqi (NFI) came in and gave them water. (b)(6),(b)(7)(C) indicated the head Iraqi also told them to give the water to V/AHMED.

**b7E**

3. (b)(6),(b)(7)(C) related he heard an IP say to V/AHMED, "you killed my brother." This was in the next cell before V/AHMED was taken out and beaten. (b)(6),(b)(7)(C) related he then heard V/AHMED screaming for about an hour. It sounded as if someone was getting beat up. It sounded as if V/AHMED was about twenty meters away when he was screaming. V/AHMED was then placed in the cell with (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C) related the American came and checked on V/AHMED. (b)(6),(b)(7)(C) stated the first time he came that he gave V/AHMED medicine. The second time the American Doctor came he tried to help V/AHMED to breathe. The third time the American Doctor came it was too late for V/AHMED and he died. (b)(6),(b)(7)(C) related he saw

the American Doctor and other American Forces try to save V/AHMED. (b)(6),(b)(7)(C) then related the American Forces then carried V/AHMED outside the cell.

4 (b)(6),(b)(7)(C) related during the time V/AHMED had been screaming and getting beaten by the IP's that he could hear that an American (NFI) had started screaming at the IP's. Could not understand English there fore he could not understand what they were saying.

(b)(6),(b)(7)(C) related he did not see the IP's with sticks. (b)(6),(b)(7)(C) advised that V/AHMED had been dressed in a gray long shirt and underwear, and had no shoes on. (b)(6),(b)(7)(C) related when the American Doctor (b)(7)(E) bruising, swelling and bleeding on V/AHMED's face, neck, chest and legs.

5. (b)(6),(b)(7) stated before he was detained he had only heard of Hashem's (V/AHMED) name. (b)(6),(b)(7)(C) advised he did not know if V/AHMED was an insurgent or not. (b)(6),(b)(7)(C) related he never saw the IP's hit V/AHMED because he was (b)(6),(b)(7)(C) t the time. (b)(6),(b)(7)(C) indicated that he saw and heard the American Forces (NFI) try to help V/AHMED, but did not know their names. (b)(6),(b)(7)(C) related he did at one time during the incident hear an American Captain (NFI) yelling at the IPs.

RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 26Sep06, Reporting Agent and Special Agent (b)(6),(b)(7)(C) met with (b)(6),(b)(7)(C) at the USMC Detention Facility at the 2nd Battalion, 3rd Marines (2/3) Headquarters, Haditha Dam, Haditha, Iraq. (b)(6),(b)(7)(C) was detained by USMC personnel and Iraqi Police (IP) in the city of Haditha, Iraq for possible participation in the kidnapping and killing of several IP (NFI). (b)(6),(b)(7)(C) was interviewed regarding his knowledge of the death of V/AHMED. (b)(7) (b)(6),(b)(7) was initially detained at the Forward Operation Base (FOB), Haditha, Iraq, before being transported to the Haditha Dam Detention Facility, Haditha, Iraq, on 26Sep06. Also present during the interview was (b)(6),(b)(7)(C) Civilian, employed by the Titan Linguist Group, who translated for (b)(7)(C) due to (b)(6),(b)(7)(C) inability to understand or speak English and only understand and speaks Arabic.

2. (b)(6),(b)(7)(C) related one or two days ago while being detained by Coalition Forces, IP (NFI) beat Hashum (V/AHMED) with "iron sticks" so bad that V/AHMED later died. (b)(6),(b)(7)(C) related V/AHMED was not beaten in the same room (cell) as he was, but that after the IP had beat V/AHMED they placed him in the same cell with (b)(6),(b)(7)(C) (b)(6),(b) related he heard V/AHMED screaming and crying, while he was being beaten by the IP. (b)(6),(b)(7)(C) advised that also in the cell with V/AHMED and (b)(6),(b)(7)(C) as (b)(6),(b)(7)(C) brother, (b)(6),(b) (b)(6),(b)(7)(C) related that an American Forces Doctor (NFI) came into the cell and treated V/AHMED. (b)(6),(b)(7)(C) related the Doctor, a white male, was called in a few times to treat V/AHMED. (b)(6), (b)(6),(b)(7) related he was able (b)(7)(E) and see the Doctor treating V/AHMED. (b)(6),(b)(7)(C) advised he saw that V/AHMED had bruises and blood on his head, neck, shoulders, legs and shins. (b)(6) (b)(6),(b)(7) related the Doctor also gave V/AHMED water, which he drank and then vomited.

3. (b)(6),(b)(7)(C) related when the IP initially came in the cell nearby his cell he could overhear an IP tell V/AHMED that he was killing people for money, not religion and that he was an insurgent. (b)(6) (b)(6),(b)(7)(C) advised the IP said when he was done with V/AHMED today he would not be able to do anything after that. (b)(6),(b)(7)(C) related that all the Iraqi prisoners could hear V/AHMED getting beat by the IP. (b)(6),(b)(7)(C) related from what he saw when his (b)(7)(E) (b)(7)(E) was that American Forces (NFI) tried to help V/AHMED. (b)(6) (b)(6),(b)(7) related when the IP brought V/AHMED to his cell after beating V/AHMED, he (b)(6),(b)(7)(C) saw the IP with "iron sticks". The IP told (b)(6),(b)(7)(C) to cover his eyes. (b)(6),(b)(7)(C) said the stick that the IP had was one to two feet long. (b)(6),(b)(7)(C) stated that he believes a Marine (NFI) came and stopped V/AHMED from being beaten any further by the IP. (b)(6),(b)(7)(C) related that an IP also said to

V/AHMED that he was an insurgent and that it was well known that he killed innocent people. The IP then said that V/AHMED had killed his brother who was twelve years old. V/AHMED said he never killed any one. (b)(6),(b)(7)(C) said he saw anywhere from four to six IP at the Detention Facility. (b)(6),(b)(7) related he saw someone that he knew, (b)(6),(b)(7) IP, at the Detention Facility, but did not think that (b)(6),(b)(7) participated in the beating of V/AHMED. On 26Sep06 (b)(6) (b)(6),(b)(7) provided a statement which was written in Arabic. (b)(6),(b)(6),(b)(7) read (b)(6),(b)(7) a statement and related the statement was written regarding his (b)(6),(b)(7)(C) knowledge of the incident of V/AHMED, Enclosure (A) pertains.
