RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 03Jan07, Reporting Agent (RA) responded to the Al Asad Surgical Hospital, Al Asad Air Base, Iraq, regarding a detainee (V/ABDAL), from the Regional Detention Facility (RDF), who was brought into the hospital unconscious and unresponsive with Cardiopulmonary Resuscitation (CPR) in progress. Upon arrival at the hospital RA wadvised V/ABDAL had died. Subsequently RA interviewed (b)(6),(b)(7)(C)(b)(6).(b) 3rd Battalion, 14th Marines, Golf Battery, RDF, Al Asad, Iraq, regarding her knowledge of V/ABDAL's death.

indicated she was the Assistant Sgt of the Guard (ASOG) on 03Jan07 and was located at the desk stationed in front of the RDF cells when the incident occurred (b)(6),(b related her position is to monitor the personnel and detainees on deck and as well as those outside talking with Humint Exploitation Team (HET) (b)(6),(reported the detainees are escorted out to the isocontainer boxes (which are the interview rooms) and she monitors the interviews via a TV screen. (b)(6),(b indicated the interviews are recorded on VHS video tapes and there is no sound.

3. According to (b)(6), detainee (b)(2) (V/ABDAL) was located in box four (4) being interviewed by a Marine named (b)(6), and an interpreter (Terp), NFI (b)(6), (b) recalled seeing that the detainee was not sitting down and she thought they were done and went out to let them back in the RDF. (b)(6),(b) ported as she was coming out the Terp ran up and said he needed a corpsman (b)(6),(b) was notified and the Terp stated the detainee had "passed away. (b)(6),(b) indicated she thought he meant passed out and she went with (b)(6), (b) to see what was going on. (b)(6), advised the detainee was lying on his back with his head facing the door and the Marine was in the box with him. (b)(6),(b) jumped in the box and started CPR. (b)(6), reported (b)(6),(b)(7)(C) (b)(6),(b)(nd the ambulance came there to assist (b)(6),(b) The detainee was put on a stretcher and (b)(6),(continued to do CPR.

 RA askec(b)(6), po describe the detained to the best of her memory. (b)(6)(b) stated the detainee had his eyes closed, his hands may have been facing up and she recalled him letting out a gasp. (b)(6), stated (b)(6),(b)(7)(C) as the one told to call 911. (b)(6),(indicated she returned to her post during the incident and had to switch to another video tape to continue recording the incident because the first tape ran out (b)(6),(b) tated she used tapes numbered 37 and 8 to record the incident.(b)(6)(advised the tapes usually go in order of how they are stacked and have the time and date written on them when used. (b)(6),(b indicated that (b)(6).(b)((NFI) was the person who handled the detainee
