RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

1. On 03Jan07, Reporting Agent (RA) responded to the Al Asad Surgical Hospital, Al Asad Air Base, Iraq, regarding a detainee (V/ABDAL), from the Regional Detention Facility (RDF), who was brought into the hospital unconscious and unresponsive with Cardiopulmonary Resuscitation (CPR) in progress. Upon arrival at the hospital, RA was advised V/ABDAL had died. Subsequently, RA interviewed (b)(6),(b)(7)(C) (b)(6),(b)(7)(C) MC, regarding his knowledge of V/ABDAL's death.

2. On 04Jan07 (b)(6),(b) provided RA with a handwritten statement regarding his knowledge of V/ABDAL's death, enclosure (A) pertains. RA asked (b)(6),(b) some clarifying questions about his statement. (b)(6),(b) advised he removed the metal handcuffs, which were attached to a leather belt that was around the detainee's waist. (b)(6),(b) related detainees are moved out of their cell and escorted to medical prior to being handcuffed and moved to the HUMINT Exploitation Team (HET) interview booths. (b)(6),(b) advised the detainees are escorted to the HET compound (b)(7)(E) (b)(6),(b) stated he removed the handcuffs when (b)(6),(b) was doing rescue breathing but could not recall who removed the belt. (b)(6),(b) reported the detainee was lying flat on his back with his head facing the door. (b)(6),(b) drew a picture depicting booth four, during the incident on 03Jan07, enclosure (B) pertains. (b)(6),(b) had no further information at this time.
