RESULTS OF INTERVIEW OF (b)(6).(b)(7)(C)

1. On 08Feb07, Reporting Agent (RA) briefly interviewed (b)(6).(b)(7)(C) (b)(6).(b)(7)(C) born 1979, a Titan L3 interpreter, at Hue City, regarding his conversation with the hospital staff with respect to V/MOHAMMED's death.

2. According to (b)(6), (b)(7)(C) they (the Marine patrol he was with) went to the hospital on 06Feb07 and talked with the hospital manager and the surgeon (b)(6),(b) reported the hospital is more like a clinic, and due to the fact it supports so many people in the city, in his opinion, not much attention is paid to those that come in deceased (b)(6).(b)(7)(C) related at first the hospital manager did not know which patient he was talking about and claimed the body came into the hospital at approximately 0400. A short time later, V/MOHAMMED's paperwork was obtained. (b)(6),(reported the paperwork matched the name they were given to look for and then he spoke with the doctor who stated he noticed bruising on the hand/wrist area and neck area. The doctor related there was an injury on the right side of V/MOHAMMED's upper lip. Additionally, the doctor stated V/MOHAMMED was only wearing underwear when he came into the hospital (NFI) and his body was given to family on 05Feb07. No one had recorded the family member who reportedly took custody of V/MOHAMMED's body (b)(6), provided no further information at this time. (b)(7)

RESULTS OF RECEIPT OF HOSPITAL RECORDS AND TRANSLATION

1. On 08Feb07, Reporting Agent (RA) traveled to Hue City Battle Position, Iraq, and was provided a copy of the medical records pertaining to V/MOHAMMED that were obtained by (b)(6),(b)(7)(C) USMC, (b)(6),(b)(7)(C) and an interpreter named (b)(6),(b)(7)(C). The group obtained the records from the local hospital where V/MOHAMMED was taken by the Iraqi police on 05Feb07.

2. The hospital documents are in Arabic and information obtained by (b)(6),(b)(7) and (b)(6),(b)(7) at the hospital is recorded under separate cover. Upon return to Al Asad Air Base, Al Asad, Iraq, RA had the documents translated at the Joint Prosecutive Exploitation Center (JPEC) Document Exploitation (DOCEX) unit aboard Al Asad, Iraq. Upon translation it was determined that under cause of death the following was written: existence of [illegible] in the neck, limbs and wraps in his hands and that the doctor's name was (b)(6),(b)(7)(C). It is also recorded that the victim's name is Hasan Salih 'Ali and his body was sent to Al-Qa'im general hospital by Ka'rab'lah police, enclosures (A)-(B) pertain.
