RESULTS OF INTERVIEW WITH (b)(6),(b)(7)(C)

 On 08Feb07, Reporting Agent (RA) was advised by (b)(6),(b)(7)(C) Kilo Company, 3rd Battalion, 4th Marines, Battle Position (BP) Tarawa, that he had been on patrol the day after V/MOHAMMED had been found deceased and had been stopped by Iraqi's wanting to show him and others what had happened during the raid on their homes. (b)(6),(b)(7)(C)

(b)(6),(b)(7)(indicated he was being shown around by an individual who later was determined to be wanted for questioning and was detained. This individual was identified as (b)(6),(b)(7)(C) RA returned to Al Qaim from BP Tarawa via convoy and determine (b)(6),(b)(was still detained in Al Qaim.

On OBFeb07, RA interviewe (b)(6),(b)(with an interpreter, named (b)(6),(b)(7) regarding his knowledge of the raids on 05Feb07(b)(6),(b)(7)(C related he was just standing on the street telling Marines how his brother was killed when he was detained for no reason (b)(6),(b)(7)(C)reported he lived in a separate house from his father and brother and was not present during the raid. It was unclear as to what house near the raided houses (b)(6),(b)(lived. (b)(6),(b)(reported he was told by those who did not get detained in the raid that people were telling owners to come to the door but allegedly his brother was shot while opening the door (b)(6),(b) related one of the neighbors was shot and died in the bathroom. RA asked (b)(6),(b) if he knew the person found dead outside of the house (b)(6)(b)(indicated he did not know him, and then claimed he was a relative of his fathers (b)(6),(b)(stated everyone from the raided house that was detained left alive. (b)(6),(b)(7)(C) related the man who died had family that lived in Beyji and he was here with his son,(b)(6),(b (NFI). According to(b)(6),(b)(V/MOHAMMED's son rented a pick up truck and took V/MOHAMMED back to Beyji. RA asked if (b)(6),(b) knew if V/MOHAMMED had been sick and he replied he previously had had a heart attack. RA asked if he could clarify how he knew that information an(b)(6),(b)(7 could not provide the information. RA asked(b)(6),(b)(who lived in the third house that was searched during the raid an(b)(6),(b)(7) reported (b)(6),(6) lived in the third house. No further information was obtained at this time.

On 09Feb07, (b)(6),(b)(7)(C) Kilo Company, 3rd Battalion, 4th Marines, Battle Position (BP) Tarawa, Iraq, provided Reporting Agent (RA) with photographs of V/MOHAMMED he had obtained from Iraqi Police Officer, (b)(6),(b)(7)(C) indicated the LT had taken the pictures prior to having V/MOHAMMED's body taken to the hospital, enclosure (A) pertains.

2. Additionally, (C) provided more photographs taken from (b)(6).(b)(7)(C) (b)(6).(b)(7)(C) reportedly taken the following day when he visited the homes involved in the raid and spoke to family members. Enclosure (B) pertains to a photograph of a burnt out vehicle which was located in the front yard of the house in which V/MOHAMMED was detained from and enclosure (C) pertains to a photograph of a bathroom reportedly located in the second house breeched during the raid in which an unidentified person died in.
