RESULTS OF INTERVIEW OF (b)(6),(b)(7)(C) AND (b)(6),(b)(7)(C)

1. On 24Feb07, Reporting Agent (RA) and Participant (b)(6),(b)(7)(C) briefly spoke with (b)(6),(b)(7)(C) and (b)(6),(b)(7)(C), USN Dog Handlers with Task Force 88, regarding their knowledge of V/MOHAMMED's death on 05Feb07. (b)(6),(b) related in his command statement, provided under separate cover, he mistakenly included (b)(6),(b)(7)(C) in his statement by saying neither of their dogs engaged the MAM (military age male). (b)(6),(b) stated he was in house (b)(2) and (b)(6),(b) was in house (b)(2) where V/MOHAMMED was detained FROM. (b)(6),(b) had no further information pertaining to (b) or V/MOHAMMED.

2. (b)(6),(b) advised he was the dog handler inside (b)(2) during the raid and his dog did not engage V/MOHAMMED. (b)(6),(b) related his dog did engage an individual in the arm and after transport (b)(6),(b) advised he checked on the person's injury. (b)(6),(b) reported the individual's arm was medically treated on scene and after transport he seemed to be fine. (b)(6),(b) indicated he briefly saw the expired detainee (V/MOHAMMED) when he was taken off the ladder but could not recall who moved him. No further information was obtained at this time.

RESULTS OF PHOTOGRAPHIC DOCUMENTATION OF A TASK FORCE 88 LADDER

1. On 24Feb07, Reporting Agent (RA) and Participant (b)(6),(b)(7)(C) photographed a Task Force 88 ladder similar to the one used during the raid on 05Feb07 and subsequently utilized as a makeshift litter to transport V/MOHAMMED to the Landing Zone (LZ).

2. The ladder measured approximately 7 feet and 1 3/4 inches long and the distance between the rungs was 10 1/2 inches. Photographs were taken utilizing a Sony Cyber Shot digital camera, enclosure (A) pertains.

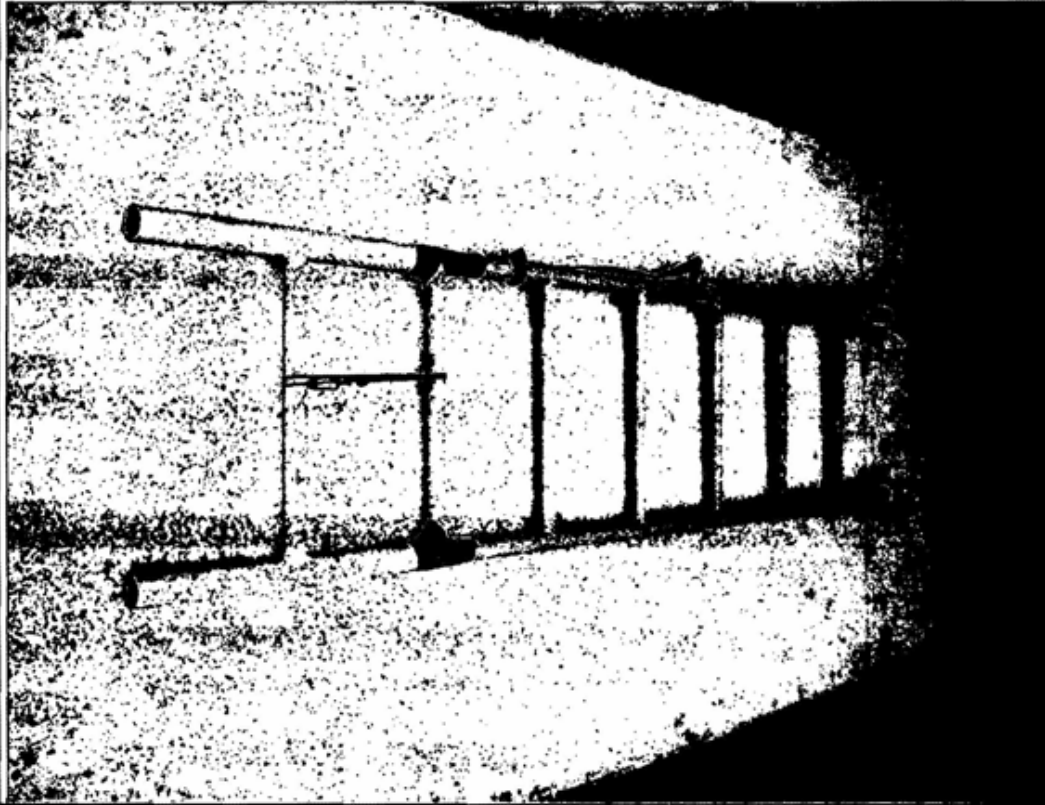

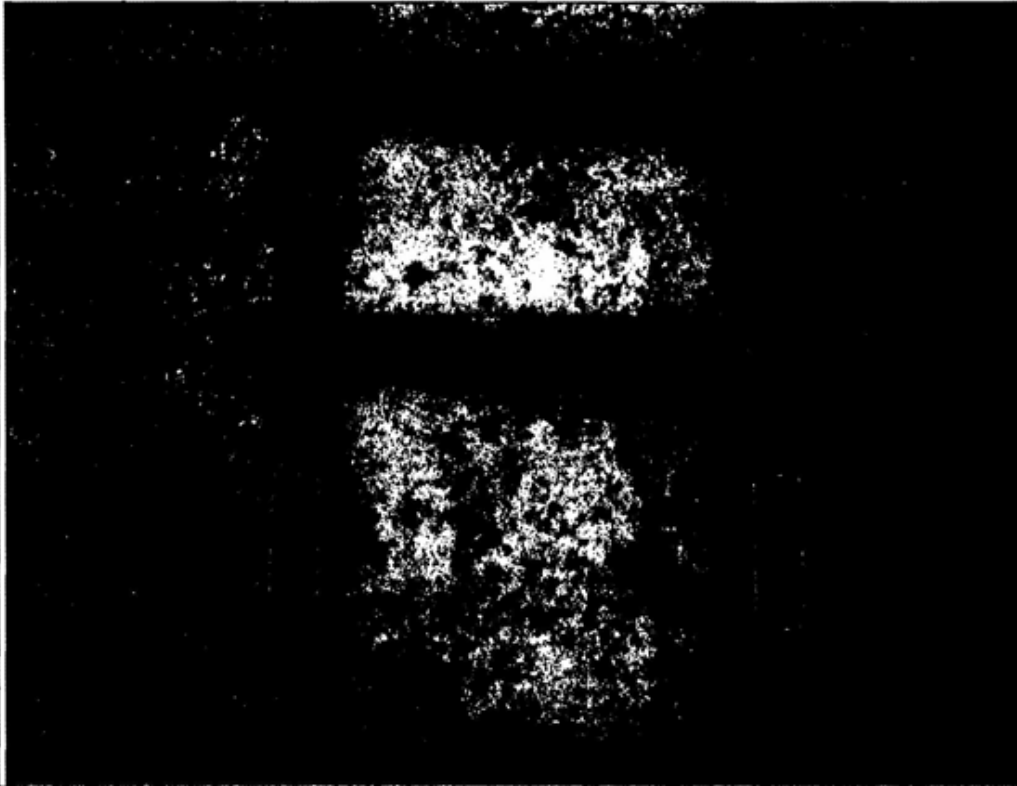

RESULTS OF ARABIC DOCUMENT TRANSLATION

1. On 09Feb07, Reporting Agent (RA) obtained a list of people reportedly detained or killed during the raid on 05Feb07 while visiting house (b)(2) to determine if V/MOHAMMED had family in the area. The list was a print out in Arabic and was provided from one of the Iraqi Nationals reported to live at house (b)(2). Upon returning to Al Asad Air Base, Al Asad, Iraq, Participant (b)(6),(b) requested translation assistance from the Document Exploitation Unit (DOCEX). On 25Feb07, (b)(6),(b)(7)(C) USN, Officer in Charge, DOCEX, provided a translation of the list, enclosures (A)-(B) pertain.

2. According to the Iraqi National who provided the list, the top half of names reflect people who normally lived in (b)(2) and the bottom half of names list four (4) people, including V/MOHAMMED, who were from Beyji and three people from Al Qaim. According to the translation the other three people from Beyji are still detained.
