It is not assessed they will trigger any specific terrorist attacks, however they will aid in long-term al-Qaida/terrorist recruitment and fund raising, and may be cited as the inspiration of near-term attacks which were already planned. It may cause spontaneous acts of anti-U.S. violence.

AHMED, ALI ABDULLAH (US9YM-000693DP) -- Significance: It is assessed that this detainee is a member of mid to high-level operative of Al-Qaida and/or its global terrorist network. Detainee has links to key facilitators and senior members in the Al-Qaida international terrorist network.
