It was hired by Titan in early October 03 to work as an Arabic language interpreter/translator. I arrived at Abu Ghraib on 11 or 12 October and left on January 19, 04. Immediately on arrival I was given a tour of the facility to include the interrogation areas, dining and sleeping areas and given an orientation on how the interrogation center functioned. I was informed of do's and don't in handling detainnees - specifically to translate exactly what was said, no physical or verbal abuse or humiliation, to sit between the detainee and interrogator. I was instructed to report immediately if I saw or became aware of any abuse or humiliation of detainees. Hand gestures were allowed as part of the interpreter process as that is a part of Arab culture. My initial assignment was in screening for about 5 or 6 days and after they found that I was more capable, I was moved to interrogations. I mainly interrogated former I rapi Intelligence Service personnel and General Officers who had previously worked with an interrogation and allowed and walked around naked or having to wear women's underwear.
