We received word L-41's crew was struck by a landmine on the eastern most Bridge in Robyn. so I called my S-Tow wrecker crew and proceeded to the scene once I arrived on the scene I looked around the tank plts had the perimeter secure so then I went to the Humvee assessed the damage, positioned my S-Tow and recovered the vehicle after the vehicle was hooked-up. I went back to my vehicle I talked to CPT [Redacted] and 4th plt. plt. leader [Redacted] asked about the soldiers in the tank on guard I returned to my vehicle CPT [Redacted] then came to my vehicle and told me we're going to retrieve the soldiers on guard at the tank we had 4th Plt. Plt. Sgt. mobilize his crew I went back to check the rig on the humvee all was good by this time my driver had positioned the vehicle behind me I returned to my truck noticed cpt. [Redacted] in front of me by a fire truck with two detainees on the ground soon after they were on their feet and released and we proceeded to retrieve the soldiers from the tank. (nothing follows)

Q. Did you see anyone assault or strike the detainees?

A. I saw them moved from the truck and placed on the ground with cpt. [Redacted] over them with his foot on one of the detainees
