The detainee sells domestic animals throughout his province so it is normal for him to carry large amounts of money after selling the animals. He claims he was taken to an American base near Balad where his clothes were cut off by American soldiers and he and other detainees were forced to stand in the rain naked for twelve hours. After ten days he was released and told to come back the next day to claim his money. When he came back on 23 January he was offered 4000 USD or an impounded BMW. He refused both offers and the 1-8 Infantry \$22, told him he must accept one of the offers or would put him back in jail. declined and said he wanted the 26000 USD he had when he was detained and no less. put him back in threatened him, told him not to file a detention for another sixteen days. From these accusations, was reprimanded a second time in January 2004, relieved from his duties for a period of two weeks and then reinstated under probation.
