I [redacted] wish to make the following statement on June 20, 2003

I was in charge of a mounted patrol in zone 45. On that night Blue Platoon (w/ Engineer Support) chased looters in vic Maide site into a field. I apprehended 1 later & in accordance w/ 1-325 SOP the detainee was Plex cuffed & hooded. Due to the dumping of garbage, dogs scavenge the area in packs. One dog in particular was dangerously aggressive towards me. I discharged a round (9mm) in vicinity of the dog. The detainee was scared by the sudden gunshot & fell to the ground crying. It was not my intent to scare the detainee, merely to defend myself from the dog. When we failed to find any more looters we cut loose the detainee & gave him ~~some~~ water bottle for the road. Before the patrol moved <sup>(left or compound)</sup> I gave a "no change" brief in the ROE & briefed my op plan FM.

I was in charge of a mounted patrol in Zone 45 on June 22, 2003. EN ROUTE TO my zone we spotted looters vic "Ammo Factory". Per SOP for that particular area my 2 victors split to block looters from escape. The engineer group called up the report that they detained 1 man, 2 kids & 1 victor. They asked me if we were "going to let them go?" & I asked if they were crying - meaning the children. Shortly after a shot was fired from vic location of the engineers. I was told that it was a warning shot & I had no reason to believe otherwise. We let the family go. Before we left for patrol I gave a "no change" brief to the ROE & briefed my op plan FM.

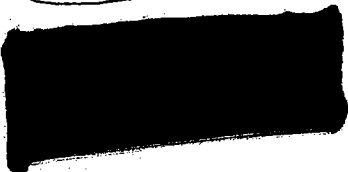
