Specification #2: In that you, who knew or should have known of your duties at U.S. Naval Station, Guantanamo Bay, Cuba, on or about 10 April 2003, were derelict in the performance of those duties in that you negligently failed to secure a detainee cell, as it was your duty to do. This is in violation of Article 92, UCMJ.

Specification #3: In that you, did, at U.S. Naval Station, Guantanamo Bay, Cuba, on or about 10 April 2003, unlawfully strike a detainee on his body with your fist after the detainee was shackled. This is in violation of Article 128, UCMJ.

1. I have reviewed the informal AR 15-6 investigation initiated on 10 April 2003, to consider actions taken by members of the 132nd MP CO and find no legal objection. The findings and recommendations are suitable for consideration for final action.
2. The proceedings comply with all legal requirements of AR 15-6 and other applicable guidance (e.g., Article 31, UCMJ). No errors are apparent on the face of this investigation.
3. There is sufficient evidence to support each finding by the Investigating Officer. Witness interviews were conducted which lead credible support to each and every finding.

SECTION IV - FINDINGS (para J-10, AR 15-6)

The (investigating officer) (board), having carefully considered the evidence, finds:

1. Neither [redacted] secured the door to Cell # 15 after returning [redacted] therein.
2. The door to Cell #15 was unsecured for approximately two hours without being noticed by any Sierra Block guard team member.
3. [redacted] was nearly successful in locking all four Sierra Block guard team members into Cell #21 because the entire guard team was standing in or near Cell #21 with their attention exclusively focused into the cell and on the search in progress.
4. The force used to subdue [redacted] was appropriate until he was shackled. [redacted] assaulted [redacted] after he was restrained by striking him with his fist.
5. Witness testimony indicates that, although infrequent, detainee cells have been left unlocked on prior occasions.

SECTION V - RECOMMENDATIONS (para J-11, AR 15-6)

In view of the above findings, the (investigating officer) (board) recommends:

1. That the JDOG Commander consider appropriate administrative and/or disciplinary action against [redacted] for dereliction of duty under Article 92, UCMJ, and against [redacted] for assault against [redacted] under Article 128, UCMJ.
2. That refresher training in block safety and security procedures be provided to all JDOG personnel.
3. That all lockplates be painted a color that will sufficiently contrast the lockplate from the lock to ease visual inspection.

Preliminary Report of Investigation
Events on Sierra Block of 10 April 2003

Sierra Block Team:



Approximately 1630:

- [redacted] return [redacted] to cell 15. [redacted] belonged in cell 16.)
- [redacted] the shackle man and [redacted] holds the keys to the cell padlock.
- Neither man can conceive of not having locked the cell door.
- Neither man can definitively state the door was locked.

Examination of the cell and cell door by [redacted] upon arrival revealed the door to be open with the padlock engaged through the receiver under the lockplate. Both beam holes were closed and secured by D-rings. Videotape taken immediately after the event shows the same door configuration.

1630 to 1830:

- Block team members rotate to chow.

Approximately 1830:

- [redacted] notices that detainee in cell 21 has contraband food. The detainee refuses to surrender the food to either [redacted]
- [redacted] returns from chow and is briefed by [redacted] about contraband in cell 21. [redacted] directs cell search.
- [redacted] place three-piece suit on detainee in cell 21 and move him to cell 29.
- [redacted] begins search of cell 21.
- Having secured the detainee in cell 29, [redacted] return to cell 21. [redacted] enters cell 21 and [redacted] stands in the doorway.

Approximately 1835:


- [redacted] are inside cell 21. [redacted] is standing in the doorway. [redacted] is standing outside but near the door. All the men are looking into the cell.
- [redacted] exits cell 15 and pushes [redacted] into cell 21.
- [redacted] prevents the door to cell 21 from being closed by forcing his arm outside. He squeezes his head and torso out of the cell and is punched in the face by [redacted] losing a tooth.
- The men push the door open and all four begin to subdue [redacted]


- [redacted] thumps his teeth into [redacted] arm and does not release until [redacted] twice strikes him in the head with his radio. These blows likely cause the lacerations to the back of [redacted] scalp.
- Others arrive and assist in subduing and shackling [redacted]
- Just as the shackling process is being completed, [redacted] becomes extremely agitated and begins yelling "you bit me! You bit me!". [redacted] strikes [redacted] and is immediately pulled away and assisted off the block.
- [redacted] is transported to medical.

Conclusions:

- Neither [redacted] secured the door to cell 15 after placing [redacted] therein.
- That the door to cell 15 was unsecured for approximately two hours went unnoticed by all Sierra block team members.
- [redacted] was nearly successful in locking all Sierra block team members into cell 21 because the men were all standing in or near cell 21 and their attention was focused into the cell and at the search being conducted.



Detainees [redacted] and [redacted] were in the Rec yard, but returned to shower. While in the Rec yard, Detainee [redacted] had been told twice by [redacted] not to practice martial arts while in the Rec yard. Detainees [redacted] and detainee [redacted] were both properly secured in a 3 piece suit before the Rec door was open. 3 piece suit was put on through the bean hole in the Rec door, and each detainee was moved one at a time. They were the last 2 detainees for shower & Rec. Being the shacklemaster, I was responsible for shackling and unshackling the detainees through the bean hole. I do not remember who assisted me in moving the detainees to the cell. They were responsible for locking the cell door. However, I would not of left them without knowing if the detainee was properly secured in their cell. Upon walking the block, we noticed several detainees had items in their cells that were not authorized for Level 4 detainees. We made some notes on each one, waiting to secure the items until all members of the block had returned from shower. [redacted] had the most contraband, therefore we decided to do him first we put him in a 3 piece suit through the bean hole, and secured him in an empty cell approx. 7-10 cells away. He was locked in the cell, still in his 3 piece suit. Upon entering [redacted] cell, [redacted] went in, [redacted] went in, and I went in. [redacted] was at the door way of the cell I immediately locked in the toilet and flushed it. I then bent down to be up under the bed when I noticed Detainee [redacted] push [redacted] into the cell from behind, and attempt to lock us in. [redacted]

After the detainee was shackled, [redacted] began to scream obscenities at the detainee. [redacted] began to scream obscenities, and tried to remove [redacted] the block. I then went running to the canopy where [redacted] opened Oscar block to let me out so I could go to Sierra block. I ran up onto the block where [redacted] and other MPs had the Detainee already on the ground without handcuffs or leg irons on. I secured the right leg while [redacted] applied the leg restraints on. We then secured the Left and Right hands behind his back [redacted] then asked me and whoever was on the right leg to bring the legs up to secure them to the handcuffs. The detainee kept to kick, but then cooperated after being told to do so by the SGT 2, [redacted]. Once secured [redacted] began screaming and yelling @ the detainee "you hit me, you hit me" [redacted] then jumped onto the detainee and began hitting him. The MPs on the block pulled [redacted] off and out of the area. We then picked the detainee up and carried him outside then the back of the block. A stretcher was waiting there with [redacted] to attend to the bleeding detainee. We then rolled him out to the canopy where [redacted] took my place and escorted him to medical. I then saw a soldier make a subsonic movement and then was pushed and being held by the cell block walls and then pushed down the floor. I met them and heard someone say "Get him off the block". I helped [redacted] off the block at that time. We got [redacted] into the yard and then [redacted] was yelling for the key to the sally port. I got the key and opened the sally port and then tried to get [redacted] to exit the block. He was in a cage and yelling get you- lums off me. I thought nothing of it because of the situation. [redacted] ordered [redacted] to leave the block. The Lt. then stayed a second time later the block is out. [redacted] started yelling, "Add what, and what" at the [redacted], myself and others were able to convince [redacted] then [redacted] was escorted to the N. and locked the sally port gate. I went to [redacted] to check on my [redacted]. I write this statement, I remember [redacted] speaking I don't recall what he said but what he looked like. His mouth was bleeding and I talked with several [redacted] with [redacted].

That approximately 1955 hrs on the twelfth day of April, year 2003, that I was working on "S" block when I heard the next block over yelling, and screaming. Then I heard on the radio yelling, "we need some fucking help, get the fuck over to "S" block." At that time I ran over to "S" block to see if I could help. I counted at least 15-25 MPs on the block already. I ran down the block where all the guys was, I saw a detainee on the ground with a MP's on top of him trying to secure him. I wanted to know what I could do to help so I took initiative and closed off both end doors. I didn't lock them cause I didn't have a key. After closing the front door off, I saw a MP grab another MP and resuscitation off the block for some reason I don't know. Then I went back down the block and met [redacted] he had blood covering his mouth. I stopped him and asked him if he was alright, he said he was fine but I noticed he was missing a front tooth. After he walked off I went back to see if I could do any thing else. [redacted] instructed me to take down all cell block numbers that were yelling during the incident, they are as follows: [redacted]. They were chanting "Allah-Week-hitts." After I did that I stationed myself at the rear door (After the detainee was resuscitated off the block) and made sure no one came in or out of the rear door so as not to walk in blood. There was a puddle of blood on the floor in the middle of the door. I assume some of it was from [redacted]. After all had been clear and there was no more news for my presence, I asked [redacted] to get one of his soldiers to release me so I could return to my block at that time [redacted] took my place.
