SUBJECT: RFI (0212-04-CID001)

1. The review of ROI # 0235-03-CID259 determined the investigation was operationally insufficient and was administratively insufficient. This investigation was reported as an SSI only report of death.
2. The review disclosed the following deficiencies. The investigation did not conduct a crime scene examination or explain why such an examination was not conducted. The investigation did not conduct any interviews to determine the circumstances surrounding the death. There was no investigative effort made to obtain the victim's medical records that could have been used to determine if he was under medical care prior to his death. The investigation was closed without opening a full Report of Investigation (ROI). The case file was closed without any preliminary or final autopsy report, or any information as to whether or not an autopsy was conducted. There was an email in the case file that the SSI ONLY email message was received, however, there was no paper or electronic copy of the SSI report in the case file.
