THE INTERVIEW WAS CONDUCTED IN URDU AS TRANSLATED BY [REDACTED]. [REDACTED] PROVIDED THE FOLLOWING INFORMATION:

[REDACTED] PROVIDED THE FOLLOWING INFORMATION ABOUT HIS TIMELINE PRIOR TO CAPTURE: APPROXIMATELY 1.5 YEARS PRIOR TO THE 30 AUG 03 INTERVIEW (CIRCA FEB 02) HE LEFT KARACHI, PAKISTAN TO TRAVEL TO QUETTA, BY BUS. HE STOPPED IN BOLDUKH, THEN TRAVELED TO KHANDAHAR AND FINALLY KABUL, AGAIN BY BUS.

[REDACTED] STAYED WITH A FRIEND IN KABUL WHO'S NAME HE COULD NOT RECALL. [REDACTED] b(7)(C)-5  
[REDACTED] VISITED HOLY SHRINES, AND STAYED APPROXIMATELY FOUR DAYS. [REDACTED] THEN TRAVELED FROM KABUL TO JALALABAD BY TAXI, WHERE HE FOUND A GUIDE TO WALK HIM TO PESHWAR, PAKISTAN. WHILE IN JALALABAD HE WAS ROBBED OF HIS CLOTHING BAG, BUT THE THIEVES DID NOT TAKE THE MONEY IN HIS POCKET. HE WALKED WITH THE GUIDE TO PESHWAR, PAKISTAN.

IN PESHWAR, [REDACTED] STAYED OUTSIDE THE MAIN CITY AND PRAYED AT A MOSQUE. HE MET SOMEONE WHO WOULD HELP HIM GET TO A BUS TO GET TO KARACHI, PAKISTAN, BUT THE PERSON TOOK HIM TO THE POLICE STATION INSTEAD. [REDACTED] PRESUMED THAT THE PERSON COULD TELL HE WAS NOT A LOCAL DUE TO HIS CLOTHING AND APPEARANCE FROM TRAVELING. [REDACTED] WAS PUT IN JAIL, AND GIVEN NO REASON FOR THE INCARCERATION. [REDACTED] FELT THAT HIS b(7)(C)-5  
REVELATION TO THE POLICE THAT HE WAS ACTUALLY FROM BANGLADESH AND ON HIS WAY TO KARACHI MIGHT HAVE MADE THEM SUSPICIOUS. HE WAS FED TEA AND BREAD, AND SOMETIME ON THE AFTERNOON OF THE SAME DAY HE WAS TRANSPORTED TO ANOTHER JAIL. [REDACTED] ESTIMATED HE HAD 4000 RUPIES ON HIM AT THE TIME. b(7)(C)-5

[REDACTED] CLAIMS NEVER TO HAVE BEEN TRAINED ON THE USE OF THE KALASHNAKOV. WHEN ASKED IF HE FELT A DUTY TO PERFORM JIHAD, [REDACTED] REPLIED THAT THERE ARE MANY OTHER FORMS OF JIHAD BESIDES VIOLENCE, AND THAT JIHAD CAN MEAN INTERNAL STRUGGLE.

[REDACTED] ORIGINALLY HAD A BAD OPINION OF AMERICANS AFTER BEING BEATEN, BUT OVER TIME HAS CHANGED HIS OPINION DUE TO GOOD TREATMENT.

[REDACTED] HAS NO PLANS AFTER POSSIBLE RELEASE, BUT HAS CONSIDERED RETURNING TO BANGLADESH TO SEEK THE COUNSEL OF HIS PARENTS TO DETERMINE A FUTURE COURSE.

THIS INTERVIEW WAS CONDUCTED BY THE TRANSFER TEAM BASED ON RECOMMENDATIONS FROM THE 27 AUG 03 ASSESSMENT REVIEW BOARD (ARB), FT. BELVOIR, VA. [REDACTED] RELATED A VERY SIMILAR STORY TO HIS EARLIER INTERVIEWS, BUT WHEN PROBED ABOUT THE REASONS HE PROVIDED A FALSE NAME UNTIL THE ARRIVAL OF THE BANGLADESHI DELEGATION, HE VACILLATED AND APPEARED GENERALLY DECEPTIVE. [REDACTED] CLAIMED THIS TIME TO HAVE BEEN BEATEN BY [REDACTED]. b(7)(C)-5

AMERICANS, AND PROVIDED THE FALSE NAME DUE TO THE DISORIENTATION ASSOCIATED WITH THE THRASHING HE RECEIVED.

PREVIOUSLY, ██████████ <sup>-b(7)(C)-5</sup> CLAIMED TO HAVE BEEN BEATEN BY PAKISTANI POLICE, AND PROVIDED THEM WITH THE FALSE NAME. HE DID NOT REVEAL HIS TRUE NAME TO U.S. AUTHORITIES UNTIL LATER DUE TO "FEAR OF BEING BEATEN AND BRANDED A LIAR." (SOURCE ██████████) <sup>-b(2)-1</sup>
