ON 24 MAR 05, THIS OFFICE RECEIVED INFORMATION FROM THE OPERATIONS OFFICER, 11TH MILITARY POLICE BATTALION (CID) (FWD), CAMP VICTORY, IZ, REPORTING RECEIPT OF REQUEST FOR CORRECTION (RFC) (0152-05-CID001) FROM UNITED STATES ARMY CRIMINAL INVESTIGATION COMMAND (USACIDC), WHICH STATED A REVIEW OF THIS INVESTIGATION HAD BEEN CONDUCTED AND DETERMINED THERE WERE ADMINISTRATIVE AND INVESTIGATIVE DEFICIENCIES.

THE OFFENSE CODE OF 6E1D3, RAPE, WAS CORRECTED TO 6C4, INDECENT ACTS BETWEEN MALES AND FEMALES, AND 5C1C, AGGRAVATED ASSAULT BY CUTTING AND STABBING, TO 5C1R2, AGGRAVATED ASSAULT: HARM INFLICTED, OTHER.

INVESTIGATION CONTINUES BY USACIDC.

[REDACTED] (MR. [REDACTED]) REPORTED HE WAS ABUSED AND RAPED WHILE DETAINED AT THE BAGHDAD CENTRAL CONFINEMENT FACILITY (BCCF), ABU GHRAIB, IZ, AND CAMP BUCCA CONFINEMENT FACILITY (CBCF), UMM QASR, IZ.

INVESTIGATION ESTABLISHED THERE WAS INSUFFICIENT EVIDENCE TO PROVE OR DISPROVE THE OFFENSES OCCURRED AS ALLEGED BY MR. [REDACTED]. MR. [REDACTED] WAS IDENTIFIED AS THE INDIVIDUAL REFERRED TO AS [REDACTED] IN THE TIME MAGAZINE ARTICLE, HOWEVER MR. [REDACTED] WAS UNAVAILABLE FOR INTERVIEW TO CONFIRM HIS IDENTITY AS HE WAS RELEASED FROM CBCF, AND HIS WHEREABOUTS DURING THE CONDUCT OF THIS INVESTIGATION WERE UNKNOWN. THE ATTORNEY FOR [REDACTED] CLAIMED HE FEARED RETRIBUTION BY THE U.S. COALITION FORCES, AND REFUSED TO FURTHER IDENTIFY HIMSELF.

7. COMMANDERS ARE REMINDED OF THE PROVISIONS OF AR 600-8-2 PERTAINING TO SUSPENSION OF FAVORABLE PERSONNEL ACTIONS AND AR 380-67 FOR THE SUSPENSION OF SECURITY CLEARANCES OF PERSONS UNDER INVESTIGATION.

Investigation established there was insufficient evidence to prove or disprove the offenses occurred as alleged by Mr. [REDACTED]. Mr. [REDACTED] was identified as the individual referred to as [REDACTED] in the Time Magazine article; however Mr. [REDACTED] was unavailable for interview to confirm his identity as he was released from CBCF, and his whereabouts during the conduct of this investigation were unknown. The attorney for [REDACTED] claimed he feared retribution by the U.S. Coalition Forces, and refused to further identify himself. *b64 b7c4*

Regarding Mr. [REDACTED] he was imprisoned from 11/24/03 to 6/6/04. He was released with no charges and an apology. While in prison in [REDACTED] he was stripped of his clothes, beaten, beaten, had his genitals permanently damaged, [REDACTED] by electricity, beaten with cables, beaten with sticks, dragged by rope, prevented from sleeping, subjected to extreme cold, restrained in awkward and painful positions, hung by feet and arms, photographed, and raped by a woman. The woman was an American interrogator with blond hair. In one instance, a tall black man with another man with blond hair, and mustache, and tall build, punched, kicked and used a metal pipe and cables. In another instance he was taken outside nude and had cold water poured on him in December weather. [REDACTED] American personnel (contractors and military) were involved.

Being an attorney with another attorney in publishing [REDACTED] we want to help [REDACTED] representing the detainees in a class action law suit pending in San Diego California. We want to help [REDACTED] in this criminal investigation. The law suit is against the contractors that were involved in the abuse. I am very interested in having these people who committed unlawful conduct brought to justice. We would consider having our clients interviewed by your criminal investigation unit if we can have some type of guarantee that our clients will not be subjected to abuse or retaliation.

DETAILS

BASIS FOR INVESTIGATION: On 24 Mar 05, this office received Request For Correction (RFC) 0152-05-CID001, from Headquarters, United States Army Criminal Investigation Command (USACIDC), which stated a review of this investigation had been conducted and determined there were administrative and investigative deficiencies within the investigation.

This case is extremely complicated due to the involvement of a Class Action Complaint (hereinafter called the lawsuit), as well as the plaintiffs' attorneys' hesitation to provide information necessary to investigate the allegations, allegedly due to the plaintiffs' fear of retribution. Further complicating this situation is the fact that some of the allegations in the lawsuit were investigated under Report of Investigation (ROI) 0007-04-CID259-80133 (death of [REDACTED], Internment Serial Number (ISN) [REDACTED] AKA [REDACTED]).

The investigation was initiated based on a Time magazine article regarding a detainee named [REDACTED] ISN: [REDACTED] AKA [REDACTED], who was allegedly abused and sexually assaulted by a female soldier. The ROI included the original lawsuit and an amended lawsuit. The lawsuit was obtained after it was established as the source of the news article. The amended lawsuit listed eight individual detainees as plaintiffs, including the estate of a deceased detainee. The amended lawsuit also listed a Plaintiff John Doe 1 and a Plaintiff Jane Doe 2 ([REDACTED] ISN: [REDACTED], as well as John and Jane Does 3 - 1050. A break down of the eight individual detainees and further action taken is as follows:

A review of the theater detainee rosters and various documents in the file revealed a clear connection, apparently familial, between Plaintiff [REDACTED] ISN: [REDACTED] Plaintiff [REDACTED] ISN: [REDACTED], and [REDACTED] is the son of [REDACTED] (who [REDACTED] now claims was tortured to death), who was the brother of [REDACTED]. Because of the relationship between the plaintiffs, because their allegations are documented in a single source document (the lawsuit) and because efforts to locate and interview them will certainly overlap, the allegations involving [REDACTED] and [REDACTED] (cousin of [REDACTED]) were investigated under this ROI to preclude duplication of effort that would result from a separate ROI.

[REDACTED], ISN: [REDACTED] was determined to be the only one of the four plaintiffs still in custody of U.S. Coalition Forces; therefore, an attempt was made to interview him concerning his knowledge of his uncle's ([REDACTED] death and to locate his cousin [REDACTED] and his father [REDACTED]. [REDACTED] had no knowledge of abuse against the other three plaintiffs; however, claimed abuse against himself, which was investigated under ROI 0214-05-CID259-36323. [REDACTED] related he and his family wanted nothing to do with the lawsuit.

On 8 Apr 05, SA [REDACTED] this office, coordinated with Mrs. [REDACTED] (215) [REDACTED] (215) [REDACTED] lead counsel on the class action lawsuit which initiated this investigation, who stated she and her coworkers had met with and interviewed approximately 120 former detainees who claim to have been abused. Mrs. [REDACTED] further stated she would be willing to meet with SA [REDACTED] and allow access to her records (work product) in an attempt to determine which statements pertain to active ROIs. *b61/b7c1*

Between 2 Jun 05 through 4 Jun 05, SA [REDACTED] and SA [REDACTED] this office, met with Mrs. [REDACTED] to discuss with her what information she had concerning allegations of detainee abuse. Mrs. [REDACTED] explained the lawsuit was to sue [REDACTED] and [REDACTED] Corporations. She and her colleagues were still in the process of locating and identifying potential victims. Mrs. [REDACTED] explained they had statements from approximately 130 former detainees; however, she had only met a few of them. She explained that she and her colleagues had been working with attorneys in Baghdad, IZ, to screen detainees and determine which complaints warranted further attention.

During the meeting, Mrs. [REDACTED] was asked to provide a list of names of those detainees who had made abuse allegations and what their specific claims were. Mrs. [REDACTED] would discuss incidents of abuse, but would not provide the names and list of specific allegations made by any of her clients. Mrs. [REDACTED] related she would have to make contact with her clients to obtain permission prior to the release of their identities to this office. She related many of her clients feared reprisals if their identities were disclosed. *b61/b7c1*

SA [REDACTED] and SA [REDACTED] brought with them a current list of Detainee Abuse investigations which were currently being investigated by this office. Mrs. [REDACTED] would only provide this office Internment Serial Numbers (ISN) to compare with current detainee abuse investigations. The only investigations matched were those listed in ROI 0188-04-CID259-80232, 0084-05-CID259-36248, and 0085-05-CID259-36249. The only documents provided concerned ROI 0085-05-CID259-36249. Mrs. [REDACTED] could not or would not provide any additional information to assist this office.

IDENTIFICATION, LOCATION, and INTERVIEWS OF [REDACTED] and [REDACTED]

The security situation in Baghdad at this time (summer 2005) is not such that CID Agents could travel into the city without severe risk of life and limb. This is due in large part to the prevalence of Vehicle Born Improvised Explosive Devices (VBIED) and Improvised Explosive Devices (IED), kidnappings, assassinations and other hazards of combat in the area. About 0938, 25 Apr 05, SA [REDACTED] coordinated with SFC [REDACTED] NCOIC, Visitation, CBI, who stated he would come by the CID office tomorrow about 0830 with a list of who visited Detainee [REDACTED] during Mar 05. Mar 05 was the time Detainee [REDACTED] brother and father last visited him. *b6/b7c1* *b6/b7c2*

About 1600, 25 Apr 05, SA [REDACTED] and Linguist Mr. [REDACTED] CBI, re-interviewed Detainee [REDACTED] who stated he was captured in his home by US forces in Desert Camouflage Uniform (DCU). The soldiers asked for him and his brother by name and then handcuffed them and removed them from their home. They traveled separate from his father, uncle and cousin. They were taken to an unknown location where they were placed in a room with his father, uncle, and cousin. They stayed there for about three hours. They put all of his family members in the same vehicle along with other detainees and took them to an island in Baghdad. They were kept over night there and then transferred to a police station run by US Forces. When they arrived at the police station the family was split up and independently questioned. Detainee [REDACTED] stated the interpreter was not translating what he said and was being disrespectful towards him, his family and his way of life. After the interviews, the rest of his family members were taken away. He stayed in the police station for approximately 17 days until he was taken to Baghdad International Airport (BIAP). He was taken into a room and told by an interpreter he would be held for 30 years. His clothes were taken from him and he was given a jumpsuit. He was then taken into a room with his face covered where he was hit in the face twice during questioning by two different people that he could not identify. One spoke English and one was an interpreter who had an accent like he might have been from the gulf region, possibly Qatar. He was only hit twice and did not know why he was hit. He was then taken back to the room he started in, at BIAP. He did not see any of his family again until visitation. His grandmother told him during visitation that his Uncle had passed away while in Abu Ghraib. Detainee [REDACTED] asked how he passed away, but was told not to worry about it. His grandmother refused to further explain. His grandfather was more than 60 years old and was in good health the last time he saw him, before he was captured. He has seen his brother and father 3 or 4 times through visitation at Camp Bucca, with the most recent time being 7 Mar 05. He asked his father and brother several times if they were ever abused or tortured while in custody and was told not to worry about it. He was unaware of any

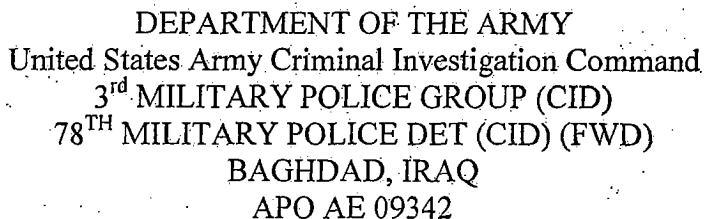

FINDINGS OF DATE REVIEW: The investigation was not sufficient. * This case is extremely complicated due to the involvement of a Class Action Complaint (hereinafter called the lawsuit), as well as the plaintiffs' attorneys' hesitation to provide information necessary to investigate the allegations, allegedly due to the plaintiffs' fear of retribution. Further complicating this situation is the fact that some of the allegations in the lawsuit were investigated under (ROI) 0007-04-CID259-80133 (death of # 2d.)

Report of Investigation

1. The investigation was initiated based on a TIME magazine article regarding a detainee named [REDACTED] who was allegedly abused and sexually assaulted by a female soldier. The ROI included the original lawsuit and an amended lawsuit as Exhibits 4 and 5, respectively. The lawsuit was obtained after it was established as the source of the news article. The amended lawsuit listed eight individual detainees as plaintiffs, including the estate of a deceased detainee. The amended lawsuit also listed a Plaintiff John Doe 1 and a Plaintiff Jane Doe 2, as well as John and Jane Does 3 - 1050. The ROI focused solely on [REDACTED] and did not address the allegations involving the other named plaintiffs. Because the lawsuit clearly documents allegations of abuse involving other detainees, each separate instance of alleged abuse must be investigated. Some of these allegations have already been investigated in other ROI, as detailed below. The remaining allegations must either be investigated under this ROI or under separate ROI if the alleged abuses are not directly related by date, time or incident.

A review of the documents included in Exhibit 7, theater detainee rosters and various documents in the file revealed a clear connection, apparently familial, between Plaintiffs [REDACTED] Plaintiff [REDACTED] Plaintiff [REDACTED] and Plaintiff [REDACTED] Plaintiff [REDACTED] is the son of Plaintiff [REDACTED] (deceased), who was the brother of Plaintiff [REDACTED]. 4. The plaintiffs listed below are unrelated and their allegations should be investigated under separate ROI: ✓

A search of the Biometrics Automated Toolset Online (BATS), the JIDC common file server and the various theater detainee rosters available to this office failed to develop any information on either of these individuals. This identification was based on the discovery of numerous detainee rosters, dated between 30 Oct 03 and 29 Dec 03, in which [REDACTED] was the only detainee whose nationality was "Sweden". This matches the reference in paragraph the amended lawsuit that Plaintiff [REDACTED] was a Swedish citizen. For unknown reasons, likely inattention to detail, subsequent theater rosters, from Jan 04 - present, list this detainee's nationality as Iraqi. An EPW property roster, also located on the JIDC server, listed [REDACTED] property as a passport and 6,250 dinar. Paragraphs 99 - 106 of the amended lawsuit detail Plaintiff [REDACTED] allegations. Because Plaintiff [REDACTED] allegations are unrelated to the other allegations in the lawsuit, a separate ROI must be initiated.

- e. Plaintiff Jane Doe No. 2. A comparison of the information contained in the lawsuit with the detainee roster and files available to this office indicates Plaintiff Jane Doe No. 2 is [REDACTED]. A detainee roster dated 30 Oct 03, reflects she was captured on 24 Sep 03, by TF 1-66, at grid coordinate LC 95488505. The roster indicated she was financing attacks (NFI). The review also indicates [REDACTED] may also be the detainee mentioned a media article on 4 Feb 05, in which she used the pseudonym [REDACTED]. Although the article lists a slightly different age (55 versus 54), according to the article, [REDACTED] was captured on 24 Sep 03, near Samara, Iraq.

- 5. The ROI incorrectly lists the offense of Rape. The victim alleges he was forced to have sex with a female in uniform. This does not meet the elements of proof for Rape and should instead be listed as Indecent Acts. *Corrected*
- 6. As documented in Exhibit 11, Mr. [REDACTED] stated he would assist in arranging an interview of Plaintiff [REDACTED] if he could be assured of his safety. Mr. [REDACTED] claimed Plaintiff [REDACTED] was fearful of retribution. Although Mr. [REDACTED] mentioned that maybe the interview could be arranged in Jordan, he did not definitively refuse to arrange an interview in Iraq. There is no follow-up on this. *Will not attempt to find*
- 7. Note that the lawsuit also includes allegations of Larceny and Destruction of Private Property. *Noted*

RECOMMENDATION: Reopen this investigation and address the aforementioned issues.

New Abuse Charges

Classified reports point to mistreatment of female detainees

Could the abuse of prisoners in Iraq have gone beyond the beatings and sexual humiliation already alleged? Unreleased, classified parts of the report on prison abuse from Major General Anthony Taguba, which were read to TIME, contain indications of mistreatment of female prisoners. In a Feb. 21 statement to Taguba, [REDACTED] former head of the Abu Ghraib interrogation center, said he had received reports "that there were members of the MI [Military Intelligence] community that had come over and done a late-night interrogation of two female detainees" last October. According to a statement by [REDACTED] boss, Colonel [REDACTED], three interrogators were later cited for violations of military law in their handling of the two females, ages 17 and 18. Senate Armed Services Committee investigators are probing whether the two women were sexually abused. The Pentagon declined to comment.

Meanwhile, a class action filed in California on behalf of former detainees raises the specter of brutal physical abuse. One plaintiff, identified only as [REDACTED] claims that after he was taken from his home on the outskirts of Baghdad last November and sent to Abu Ghraib, Americans made him disrobe and attached electrical wires to his genitals. He claims he was shocked three times. Although a vein in his penis ruptured and he had blood in his urine, he says, he was refused medical attention. In another session [REDACTED] claims, he was held down by two men while a uniformed woman forced him to have sex with her. "I was crying," said [REDACTED] 28. "I felt like my whole manhood was gone." The class action also claims that detainees were raped in prison. On June 6, [REDACTED] was released, after a U.S. civilian told him, he says, that he had been wrongly accused by informants. A U.S. military spokesman in Baghdad confirms that a prisoner with [REDACTED] ID number was released on that date, and TIME has obtained a copy of his release order. But the Pentagon would not comment on the specifics of [REDACTED] account.

I have been reviewing this ROI and attached court documents concerning a class action suit against all kinds of people and organizations and feel this case may need your attention.

The detainee's name was identified as [REDACTED] later id'd as [REDACTED] who according to a Time Magazine article claimed he was taken from his home on the outskirts of Baghdad, IZ, last November 2003, and sent to Abu. While there he was forced to disrobe and attached electrical wires to his genitals and shocked, which ruptured veins on his penis and refused medical attention. He also alleged he was held down by other guards and forced to have sex with a female soldier, while blindfolded with a bag. Other parts of the file state he was forced to strip naked, and a dog leash was put around his neck and he was forced to be on his hands knees with other detainees.

I have the detainee file from BCCF, which has limited information. The one thing that stands out from the rest of the cases here on the TF is that he claims he was abused by guards BCCF and BUCCA, not taken by unidentified individuals and interrogated, which has been the norm in our cases.

We took a look at your spreadsheet and didn't find any information for this individual, and he is not identified in the report from CID Command at the behest of MG RYDER, but he is identified in the Class Action suit.

The detainee was moved to BUCCA and has since been released. He was never interviewed by CID and I have been unable to find any additional records for him, other than the minimal paperwork included in his detainee record from BCCF.

I have come to the end of my leads and just wanted to check with you to determine if you had any interest in this one, before I suggest to Mr. [REDACTED] that we close it down.

 I spoke with Mr. [REDACTED] on Monday evening (13 Sep) he actually returned my call. He had been in Iraq for a couple of weeks so I am assuming that's why you couldn't get a hold of him. Here is my entry for that conversation:

About 1830, 13 Sep 04, SA [REDACTED] interviewed Mr. [REDACTED] who related he had just returned from spending two weeks in Iraq. Mr. [REDACTED] met with Mr. [REDACTED] while he was in Iraq along with several other alleged victims of the detainee abuse. Mr. [REDACTED] was not willing to provide any identifying information pertaining to any of the victims due to the victims' fear of repercussion for speaking about the alleged abuse. Mr. [REDACTED] related he wanted to be cooperative for this investigation, however, if there was no way to protect the victims' identity he was not willing to provide any further information other than abuse that occurred.

AGENT'S COMMENT: SA [REDACTED] advised Mr. [REDACTED] there would not be an investigation if there was no victim to step forward and make a complaint to law enforcement officials.

So, Mr. [REDACTED] is having SA [REDACTED] go and try to talk to him again. ([REDACTED] was going up there already anyways). I don't know the outcome of that as of yet. Just keeping you informed.

My name is Special Agent [REDACTED]. I am a criminal investigator, currently stationed here in Baghdad, Iraq. I recently received the Sworn Statement you provided to SA [REDACTED] concerning Mr. [REDACTED]. At the conclusion of the interview you indicated an interview may be possible, if it could be arranged for in Jordan. I will coordinate with the CID office in Camp Doha, Kuwait to determine if the interview is possible there. What I need to know from you is whether or not Mr. [REDACTED] will be able to travel Jordan to complete the interview? I will coordinate with my higher headquarters concerning Mr. [REDACTED] safety, but I don't know what could be done with that respect. I do know the information in our investigative reports are maintained by CID and the U.S. Army Crime Records Center, which would handle anything concerning the release of investigative information at the conclusion of the investigation. As far as Mr. [REDACTED] fear of safety, I fully understand, especially if the information he has provided is accurate, but as you well know we have been tasked to investigate all allegations of abuse, and without his cooperation, I don't see how we could proceed any further.
