(U) This investigation was initiated upon receipt of Memorandum of Transmittal (MOT)  
(0093-04-CID789) from the 75<sup>th</sup> Military Police (MP) Detachment (DET), Baghdad  
Central Confinement Facility (BCCF), Abu Ghraib, IZ, APO AE 09342 (AGI), which  
related [REDACTED] reported he was abused while detained in Mosul, IZ.

Investigation determined [REDACTED] was arrested on two separate occasions, 25 Apr 04, and  
21 May 04. After his first arrest, [REDACTED] was taken to the Mosul Airfield, Mosul, IZ, and  
interrogated. [REDACTED] spent approximately 8 days at the Mosul Airfield and was  
mistakenly released on or around 3 May 04. [REDACTED] was again arrested on 21 May 04  
and taken back to the Mosul Airfield and interrogated again. [REDACTED] remained at Mosul  
until he was transferred to the BCCF, Abu Ghraib, IZ, on or around 9 Jun 04.

Investigation also determined the apprehending unit was [REDACTED]  
[REDACTED] both times [REDACTED] was arrested.

[REDACTED] alleged he was abused on the scene of his first arrest on 25 Apr 04, by being  
punched in the back of the head two times and told to "shut up" while he was handcuffed  
behind his back and on his knees. He alleged he was then transported to the Mosul  
Airfield, Mosul, IZ, and kept at a place called "The Disco." During his interrogations at  
"The Disco" [REDACTED] alleged he had his jumpsuit filled with ice and was made to lay  
down on a floor with bags of dirt placed on his legs so he could not move; held down and  
punched on his head; hit with "smooth rocks" all over his body, shoulders and head; and  
slapped, punched and kicked. [REDACTED] also alleged he had two of his molars broken while  
being punched. Further, [REDACTED] alleged he had water poured in his mouth and nose until  
he fainted, and was forced to stand in front of an air conditioner in wet clothes. [REDACTED]  
also claimed he had his face rubbed in urine on the floor, and someone stomped on his  
groin. [REDACTED] further alleged he was abused in the same manner during interrogations  
after he was arrested the second time.

[REDACTED] described how he was taken to different facilities at MOSUL; one facility is  
where he was abused and the other he was treated well. Investigation determined both

Army and Navy personnel had separate interrogation facilities and both Army and Navy personnel interrogated [REDACTED]. The army interrogators were identified and interviewed and denied abusing [REDACTED] or witnessing him being abused. Screening reports completed at the time of [REDACTED] interrogations with Army personnel have been obtained and there were no signs of abuse noted. Obtained from Army personnel were 5 detainee questionnaires which ask detainees how they were treated while detained at the Army detention facility. [REDACTED] stated on all the questionnaires he was treated well at that facility.

All medical documentation pertaining to [REDACTED], which was obtained from Army sources, has been reviewed and there was no medical evidence to support his allegations of abuse. Further, Army doctors and medical personnel who examined [REDACTED] have been interviewed and related there were no physical signs of abuse.

Documentation obtained from Navy personnel confirmed [REDACTED] was captured both times by members of [REDACTED] and was also interrogated by Navy and/or Marine personnel while at the Mosul Airfield. It is strongly believed that if the alleged offenses occurred they were perpetrated by members of the U.S. Navy or Marine Corps. All U.S. Army leads have been exhausted; therefore, this investigation is referred to the NCIS for action deemed appropriate.

On 13 Apr 05, the undersigned conducted a review of this case file and noted the following:

The detainee [REDACTED] initially alleged he was abused three different times; during his initial arrest on 25 Apr 04, during subsequent interrogations to his first arrest; and again after his second arrest on 21 May 04. [REDACTED] allegations are as follows:

During his first arrest on 25 Apr 04, [REDACTED] alleged he was forced to kneel in the floor, put a bag over his head, handcuffed his hands behind his back and was punched in the back of the head two times and told to "Shut Up."

[REDACTED] alleged he was interrogated after his first arrest and during those interrogations he abused. [REDACTED] alleged he had his jumpsuit filled with ice and made to lay down on a floor and had bags of dirt placed on his legs so he could not move; held down while several people punched him on his head; had someone hit him with "smooth rocks" all over his body, shoulders and head; slapped, punched and kicked; had two of his molars broken while being punched; had water poured in his mouth and nose until he fainted; and was forced to stand in front of an air conditioner in wet clothes. Further, he alleged he had his face rubbed in urine on the floor where he was being interrogated; someone stomped on his groin; hit with smooth stones on the head about twenty times; and had someone hit him on the back of the neck with bags of ice.

On 13 Jul 04, [REDACTED] was interviewed by CID, and related after his arrest he was taken to the Mosul Airport to a place called "The Disco". [REDACTED] claimed his abuse occurred at "The Disco". Further [REDACTED] alleged at one point he passed out because of his abuse and woke up in a small wooden room with several IV's and medical devices attached to him. He is not sure how long he was there, but was taken back to the same area and interrogated again. [REDACTED] estimated he was at the "Disco" two days and then transferred to the detention facility in Mosul. There, [REDACTED] claimed he was medically screened and asked how he was treated. [REDACTED] claimed he asked the screener if he was talking about the "Disco" or the detention facility and the screener replied he only wanted to know about the detention facility. [REDACTED] claimed he was taken back to the "Disco", interrogated again, and was abused. [REDACTED] claimed he was released after a few days, but was captured again about 19 days later and returned to the "Disco" where he was abused during his interrogations again. [REDACTED] described the interrogators who were involved his abuse as 1) tall white male, blue eyes, blond hair, blue jeans and green t-shirt, 2) short, white male, glasses, small brown mustache, blue eyes, about 19 years old, 3) black male (NFI). [REDACTED] also stated he saw a tall white female, fat, blond hair in a ponytail, wearing glasses who talked to him while at the "Disco."

Investigation to date has determined the apprehending unit was [REDACTED] both times [REDACTED] was arrested. Statements from members of [REDACTED]

the apprehending unit were included in [REDACTED] detainee file. The statements all reported [REDACTED] did not resist arrest or show an aggressive posture. There was no indication in any of the statements [REDACTED] was injured during his arrest.

He claimed the first facility is where he was abused and then taken to another facility where he was medically screened and asked how he was treated, but requested to only comment about his treatment at the second facility.

SPC [REDACTED] was identified as one of [REDACTED] interrogators. SPC [REDACTED] was interviewed by CID and related he remembered [REDACTED] was initially interrogated by the [REDACTED] prior to him being turned over to the ARMY Military Intelligence units for interrogation. SPC [REDACTED] also stated he remembered [REDACTED] because the [REDACTED] came back and re-interviewed [REDACTED] which he thought was odd. Further, SPC [REDACTED] stated he did not see any abuse of detainees, but expressed concern about how some of the detainees were treated by the [REDACTED] to include [REDACTED] SPC [REDACTED] corroborated at least part of [REDACTED] statement when [REDACTED] stated he was asked about his treatment while in custody. SPC [REDACTED] stated before he would interrogate a detainee he would visually inspect them and have the detainee write or dictate a statement concerning their treatment during the interrogation. There were 5 statements obtained from SSG [REDACTED] written in Arabic with English translation pertaining to [REDACTED] The statements were to provide detainees an opportunity to describe their treatment while in U.S. Forces Custody. Four of the statements ask detainees to "Describe your experience in the custody of coalition forces" and one statement ask detainees "I was/was not physically harmed during the detainee process or during interrogation by U.S. or Coalition Forces." [REDACTED] answers on the forms all indicate he was treated very well "in this location."

A review of [REDACTED] medical documents does not support his allegations of abuse. Further, [REDACTED] was medically screened every time he was transferred between Navy and Army personnel and there were no noted injuries. The initial medical screening done when [REDACTED] was in-processed to the Baghdad Central Confinement Center, Abu Ghraib Prison (BCCF), noted some bruising around his right eye and face and a broken right molar. A Dentist examined [REDACTED] broken molar and was unable to determine whether or not the damage was a result of a punch to the right jaw as alleged by [REDACTED] He did state there were some inconsistencies with the allegation in relation to the damage, but it was possible.

Investigation also determined [REDACTED] was interrogated by both Army and Navy Personnel. Two Army interrogators have been identified as having interrogated [REDACTED] and both were

interviewed. Both denied abusing [REDACTED] or witnessing him being abused. Neither matched the description of the interrogators described by [REDACTED]

The Guard Force Commander, SSG [REDACTED] for the Mosul Detention Facility (MDF) and the earlier Eagle Detention Facility (EDF) was interviewed, who related he remembered [REDACTED] being apprehended twice and turned over to Army custody by [REDACTED] both times. Both times [REDACTED] was medically screened and there were no noted injuries. SSG [REDACTED] provided two "Primary Surveys" (medical screening forms) pertaining to [REDACTED]. There were two signatures on the forms as witnesses to the medical screenings. Basis of Investigation: On 2 Jul 04, the 504th Military Intelligence (MI) Brigade (BDE), Joint Interrogation and Debriefing Center (JIDC), Baghdad Central Confinement Facility (BCCF), Abu Ghraib, Iraq (AGI), reported that Detainee [REDACTED] National Detainee Reporting System (NDRS) [REDACTED] alleged he was abused while detained by US Forces at an unknown location prior to his arrival at BCCF, AGI.

About 0900, 2 Jul 04, this office received a statement written by Ms. [REDACTED] CACI, JIDC, BCCF, AGI detailing [REDACTED] abuse allegations. (See Statement)

About 0900, 6 Jul 04, SA [REDACTED] obtained Medical Records from the 391<sup>st</sup> Military Police (MP) BN, Detainee Aid Station (DAS). The medical screening dated 7 Jun 04, noted abuse allegations consistent with those recorded by Ms. [REDACTED] (See Medical Records)

About 2030, 7 Jul 04, SA [REDACTED] queried the Biometrics Automated Toolset (BATS) and verified that [REDACTED] was interrogated on 17 Jun 04 and 20 Jun 04. It was determined that Ms. [REDACTED] was present during both interrogations. (See Interrogation Record)

AGENT'S COMMENT: No other interrogators were interviewed, due to the fact that Ms. [REDACTED] was present during both interrogations.

About 2100, 7 Jul 04, SA [REDACTED] interviewed Ms. [REDACTED] who stated that she was present at both interrogations with [REDACTED]. She stated at no time during the first interrogation did [REDACTED] state he was abused. She stated that she did not exploit the abuse allegations, but recalled [REDACTED] being very specific about being beat with a smooth rock. She did not see any bruises or marks consistent with [REDACTED] claims, but related that the alleged incident occurred about 21 May 04. She also related that several detainees have mentioned being detained at the "Disco" at the Mosul Airport. She could not relate any other information other than that reported in her previous statement.

About 1930, 12 Jul 04, SA [REDACTED] reviewed the detainee file of [REDACTED]. He was captured by [REDACTED] in Mosul. The file was not clear as to [REDACTED] capture date. The legal documents and one statement are dated 21 May 04, while other statements are dated 25 Apr 04. There are two medical screenings. The first, dated 29 Apr 04, makes no mention of injuries consistent with [REDACTED] allegations, but does note a swollen left middle finger from a previous injury. The medical screening, dated 21 May 04, notes no injuries. Statements pertaining to [REDACTED] arrest note that he did not resist arrest nor did he show any aggressive posture. (See Detainee File)

About 1130, 13 Jul 04, SA [REDACTED], with assistance of Linguist [REDACTED] this office, interviewed Detainee [REDACTED], provided a Sworn Statement pertaining to his abuse allegations. He explained he was actually captured twice. He was captured on an unknown date in Mosul and held at the airport. Once he was released, he was recaptured again 19 days later in Mosul and held

again at the airport in Mosul. During his first capture, he was arrested at the home of his friend [REDACTED] at 0130 hrs, unknown date, by five soldiers in US Army Desert Camouflage Uniforms (DCU) in black masks. He remembered seeing a patch on the sleeve of the uniforms, which looked like the head of an Indian, which he sketched on paper. There was one Iraqi Linguist present wearing the same type black mask. He could hear helicopters outside and heard at least two military vehicles. They kneeled him on the floor, put a plastic standard army green sandbag on his head, and tied his hands behind his back with plastic flexi cuffs. He was punched in the back of the head twice and told to "Shut Up". He was then loaded on the back of a military vehicle, similarly described like a M-998. While in the truck, he was punched in the back of the head twice. He was taken to the Mosul airport, to what is commonly called "The Disco" by local Iraqi people, because music is heard coming from the location all day each day. When he arrived, he was taken into small wooden room, where his hood was removed and his hands freed. He was stripped of his clothing, place in a blue jumpsuit, and his picture was taken. He was then rehooded with the same hood and flexi cuffed behind the back. Cold water was then poured on him. He guest it was 0500 hrs the same morning. He was taken to a place with loud speakers. He stated he passed by a fire, because he could feel the heat. His jumpsuit was opened and filled with ice. He was then laid down and the remaining portion of his jumpsuit was filled with ice. A bag of ice was placed behind his head. Then four or five men speaking English started asking questions while kicking and stomping him. One American was speaking Arabic. He could tell by the dialect. He lay on the ground until the ice was almost melted. He was sat up and rocks placed in the back of the jumpsuit, and dragged by his feet for about 10 minutes. He remembers the Arabic speaking American and one other Iraqi Linguist talking to him. His hood was pulled up to his nose by a different interrogator and water was forced in his mouth and nose. The interrogator would lift him up and punch him in the back until the water came out. This happened twice. He then passed out and woke up in a small wooden room with several IVs and other medical devices attached to him. His head was not covered nor his hands tied. He saw what he thought was a doctor. He described the doctor as a white man, with a light brown beard and glasses. He stated that everyone was nice. He does not know how long he was there. Sometime after, a white male with no facial hair, in uniform pants and brown t-shirt, tied cloth around my eyes, but left his hands free. He was then driven in the back of a military truck to what he believes is the same place, because he heard the music. He was taken to a three-sided cement structure about four feet tall and no roof, where he was unhooded. It was located outside under camouflage netting. He was then taken into a small wooden interrogation room, unhooded, and hands flexi cuffed in front. He was sat in brown plastic chair. He saw and heard a man with the same voice as the one pouring water in his mouth. He described him as a tall white male, with blue eyes, blond hair, blue jeans and green t-shirt. He also a second man as short, white, with glasses, a small brown mustache, blue eyes, and appeared to be about 19 years old. He stated the short man spoke Arabic, was wearing blue jeans and a brown t-shirt, and was spitting in a Pepsi can. The two men attempted to interrogate him, but could not due to the different dialects between the linguist and [REDACTED]. The tall man jerk [REDACTED] head back and placed a bag over his head. The tall man then walked him out the door and kicked him in the butt. As he was guided down a short hallway, the tall man hit him in the head with a water bottle in

the back of the head. He was taken to the same cement box area, where ice was placed on his crown and stomach, while he lay on the ground. Rocks were thrown at him and he was hit with wooden boards. He estimated he was there for about two days. He was then loaded into a truck and taken to the detention facility at the airport in Mosul. When there, he was medically screened and asked, "How did you get treated here?" He asked the screener if he was talking about the "Disco" or the detention facility. The screener replied that he only wanted to know about the detention facility. Later that night, about 2100 hrs, three men took him, while blind folded with taped goggles, to a milvan with loud music and red lights on the floor. The three men began to punch him in his head, on all sides, about 20 times. As they punched him, they would scream in his ear. He could see partially through his goggles, and saw a black male in uniform, piss on the floor of the milvan. He said the black male then took the goggle off and rubbed his face on the floor in the piss. It was somewhat dark in the milvan, so he could not describe the black male. He said the black male punched him as he was rubbing his head on the floor. He said this lasted for ten minutes. They left him alone and the door to the milvan opened. He saw a white female in civilian clothes walk in. She had blond hair pulled back in a ponytail wearing glasses. He described her as being tall and fat. He said it was still dark outside. She told him that she knew he had been tortured, but she was his friend. She talked to him for a while. He was then taken back to the detention facility. He believes it was about 0400 hrs. He went back through the medical screening and was asked the

same question. He was again instructed to only answer about the detention facility. While at the detention facility, he saw the same black male working there. At 1400 hrs the same day, he was taken back to the "Disco". He was taken into a room, while hooded with the same green plastic bag, where more ice was placed on him. He was beaten on the body more and once stomped in the crown. At some point he was hit with several smooth stones in the head about 20 times. He said they were not thrown, but rather held by someone's hands. He was leaned over while sitting on the floor and hit with a bag of ice on the back of the neck about eight times. After a few days, he was taken back to the detention facility and released.

He was again captured 19 days later and taken back to the "Disco". While at the "Disco", he incurred the same type of treatment, to include being beat with rocks, covered in ice, and kicked. He described that when he arrived, someone said, "your #3", because they recognized him. He was then taken to a small black wooden room where the same tall interrogator entered the room and immediately punched him in the right jaw. [REDACTED] stated he was held for 7 days before being sent to the detention facility. [REDACTED] showed this Agent scars on the right side of his face, which he stated was a result of his face being rubbed in the piss. He also showed this Agent a broken tooth he alleged to have sustained when he was punched in the jaw. (See Sworn Statement, Translation of Statement and Sketch)

AGENT'S COMMENT: [REDACTED] could not write Arabic well therefore, details of the interview were recorded by this agent in this AIR.

I got arrested with [REDACTED] and his brothers in faldi area for the first time they took us to the airport a known area because of the sound and the Iraqi detainee call it disco and I stayed there about 3 days and in this place they put ice in my overall and my hand were cuffed behind my back and bag over my head and It was so hard to breath because there were not enough oxygen coming in and they start hitting me on my head my face and kick me on my stomach and my side repeatedly without sleep or giving me a chance to relax and with out food or drink and the put broken gravel in my overall with ice and the dragged me all over the floor with kicking and punishing me and hitting me with a wooden stick and a bag of ice on my nick 8 times then I got released then they arrested me again after 19 days and they beaten me torture me again with stones in a cold room for 3 days then I stayed in prison for 11 days.

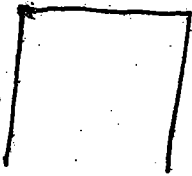
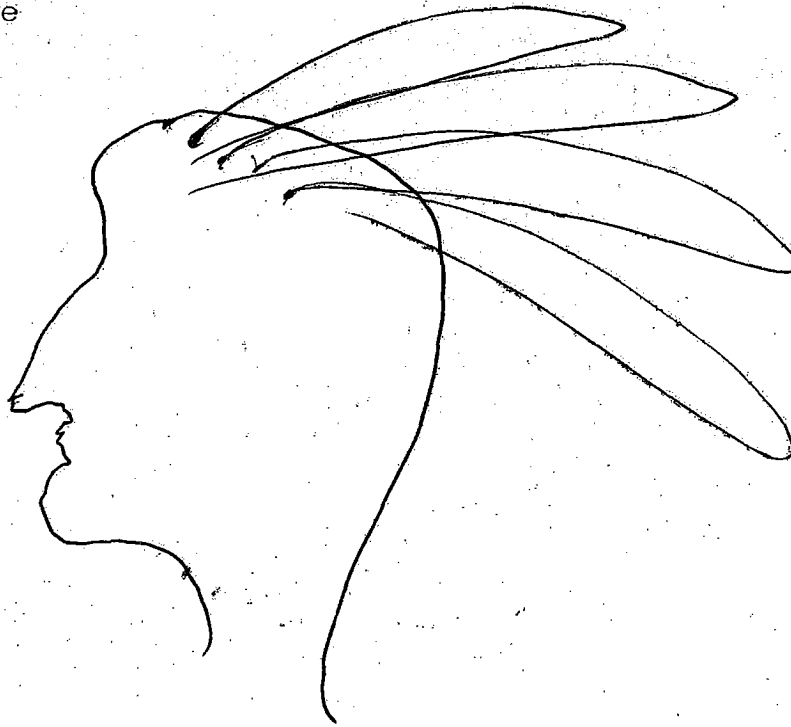

He related that it was the detention facility's practice to perform a mutual medical screening of detainees when they first arrived at MAF so there would not be any dispute regarding documentation of injuries. This practice was implemented to protect the capturing unit and detention facility from false accusations of abuse. The practice involved an examination of the detainee by a Navy Corpsman as soon as possible after capture. The examination would be witnessed by a member of the EDF/MDF staff who would review the medical survey and sign it indicating the form was an accurate representation of the detainees physical condition. SSG [REDACTED] stated that capturing units are authorized to maintain custody of detainees for 72 hours before they have to be released or turned over to MDF. He also stated that a detainee can later be checked out of the detention facility by the capturing unit, typically for 24 hours, with approval of the Provost Marshal. SSG [REDACTED] stated that all documents related to the detention and interrogation of Mr. [REDACTED] would have been sent with him when he was released to Corps. SSG [REDACTED] indicated that Mr. [REDACTED] was interrogated by Military Intelligence (MI) while he was incarcerated in EDF and MDF. b61/b7c4

SPC [REDACTED] reported a National Guard Corporal (NFI), who assisted in guarding the detainees at the [REDACTED] facility, had related the [REDACTED] abused the detainees. SPC [REDACTED] said he had often received other detainees from the [REDACTED] who had appeared to be beaten and or burnt. SPC [REDACTED] stated he would visually inspect the detainees before interrogating and have the detainee write or dictate a statement concerning their treatment during the interrogation. SPC [REDACTED] related both the statement and a copy of the visual inspection should be documented in the detainee file. SPC [REDACTED] related when Mr [REDACTED] was interrogated he was placed in the Army's version of the "Disco". SPC [REDACTED] related while at the Army's "Disco", which was built by CW3 [REDACTED] in response to pressure to provide more intelligence, had followed all guidelines outlined in their Interrogation Rules of Engagement (IROE). SPC [REDACTED] related until the newer IROE was published, as a result from the incidents at Abu Ghraib, he felt the interrogations methods outline under the old IROE were "walking the line."

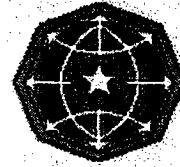

During interrogations at "The Disco" [REDACTED] alleged he had his jumpsuit filled with ice and was made to lay down on a floor with bags of dirt on his legs so he could not move; held down and punched on his head; hit with "smooth rocks" all over his body, shoulders and head; and slapped, punched and kicked. [REDACTED] also alleged he had two of his molars broken while being punched. Further, [REDACTED] alleged he had water poured in his mouth and nose until he fainted, and was forced to stand in front of an air conditioner in wet clothes. [REDACTED] also claimed he had his face rubbed in urine on the floor, and someone stomped on his groin. Are there any new developments?

I interviewed a soldier who was at the Mosul facility. Here is a brief (draft) synopsis from my report:

At 1000, 2 Nov 04, the undersigned interviewed SPC [REDACTED] 202nd Military Intelligence (MI) Battalion (BN), Camp Slayer, IZ, who related he had interrogated Mr [REDACTED] while stationed at the Mosul Facility, IZ. SPC [REDACTED] related he had seen no one abuse Mr [REDACTED] but expressed his concern over the treatment of detainees, to include Mr [REDACTED] by the [REDACTED] who were located at the Mosul detention facility. SPC [REDACTED] related Mr [REDACTED] was captured by the [REDACTED] and initially interrogated at the [REDACTED] facility, which was located on the [REDACTED] compound in the Mosul Facility. After the initial interrogation Mr [REDACTED] was turned over to the MI for interrogation and a few days later was taken back to the [REDACTED] and interrogated again. SPC [REDACTED] thought it odd the [REDACTED] would re-interview Mr [REDACTED] since they would normally turn detainees over to the Army only if they had completed the Navy's interrogation. SPC [REDACTED] related he probably would not have remembered Mr [REDACTED] if the re-interview by the [REDACTED] had not been conducted. SPC [REDACTED] related Mr [REDACTED] had been mistakenly taken to the gate and almost released but was brought back into the Mosul Facility and at a later date released. SPC [REDACTED] described the [REDACTED] facility as having strobe lights and played loud music to disorient the detainees. SPC [REDACTED] related he had not been in the [REDACTED] facility only heard others describe it. SPC [REDACTED] reported a National Guard Corporal (NFC), who assisted in guarding the detainees at the [REDACTED] facility, had related the [REDACTED] abused the detainees. SPC [REDACTED] said he had often received other detainees from the [REDACTED] who had appeared to be beaten and or burnt.

At this time I am trying to locate the National Guard Corporal. I hope this helps things on your end.
