WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
[REDACTED] was detained on 24 MAR 04 and placed on Intel hold by authority of CARSOPT-52. While detained, [REDACTED] was cooperative and showed remorse for his involvement in Anti Coalition activities. During interrogation, [REDACTED] stated the following:

[REDACTED] stated that he did take part in 6 attacks on CF. He stated that his group was comprised of 4 individuals. A man known only as [REDACTED] was the IED maker and IED handler. A man named [REDACTED] was the IED trigger man. A man named [REDACTED] would pull local security while the IED was being emplaced. [REDACTED] was later replaced by a man named [REDACTED] who would also pull local security.

2. [REDACTED] explained in detail 6 attacks that he had been involved with in October 03.

- a. The first attack was an IED attack in which they planned on hitting Coalition vehicles on Rashid Highway in front of the MICE school. The IED initiated too early and hit a 50 passenger bus where the driver of the bus was killed and 2 personnel injured.
- b. The second attack was in the same location but no injuries incurred because the IED was initiated after the Coalition patrol passed.
- c. The third attack was in the same location but it did not go off.
- d. The fourth attack was in the vicinity of the communication center in Al-Adamiyah.
- e. The fifth attack was on 20th street and was detonated by mistake at midnight and no one was injured.
- f. The sixth attack was on Omar street.

3. [REDACTED] stated that his group was being financed by his brother [REDACTED]. [REDACTED] stated that he was being paid \$75,000 (ID) every 3 days by either [REDACTED] or [REDACTED]. [REDACTED] had sold some land to help finance ACP and [REDACTED] returned from Haaj with a large amount of money.
