9. STATEMENT (Continued) But they didn't do it because they had kids with them, but they will attack once again. There is a car park in front of Abu Hamza House they used to gather there and have meetings. The Jeddahis that meet there [REDACTED] he was in the demonstration and threw grenades. And there is [REDACTED] he attacks U.S. Army. And the one who provides them by money and weapons is [REDACTED]. And the cars that might be found in the car park full with weapons, and it might be found after 6:00 P.M. The cars are red B.H.W. it belongs to [REDACTED] Mercedes 300 belongs to [REDACTED] and gray Toyota supra it belongs to [REDACTED] with another car which is yellow sunny car.

[REDACTED] he used to attack U.S. Army and the person who provides him to [REDACTED]. Four days ago a person from Houriah area came to me and gave me IEDs because he was taking it to my friend [REDACTED] but he didn't find him so he gave it to me when I found that it was IEDs I throw it in a trash case, and when [REDACTED] knew that he came asking for the IEDs, so I told him I throw it in the river so he start to be upset. He thinks that it's still there but he doesn't want to get it he said that it is without reactivated. [REDACTED] he always carry grenades in his pocket to attack U.S. patrols, [REDACTED] works with nothing follows
