WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I made the following comments to the Investigating Officer, [REDACTED] 10 June 04:

The guidance I have from my FOB is to get the detainee information paperwork straight, determine what category the detainee is, and turn over the detainee to the CP as soon as possible. Anything beyond that will require permission from the FOB. If more time was required, the detachment commander would contact me and I would get permission from the FOB. That's our FOB's SOP, not a regulation. Under normal circumstances, from the time of capture the detainee should be turned in to the DCCP within four hours. The longest I think we would be required to keep a detainee, which would require FOB approval, is 24 hours. It would be an extreme circumstance to keep a detainee beyond that [REDACTED] in Mosul so communication with them by radio. [REDACTED] Regardless of the distance from the DCCP, [REDACTED]
