INVESTIGATIVE SUMMARY:

On 28 May 04, during an administrative review of Report Of Investigation (ROI) 0003-04-
CID149-83130, it was determined that on 18 Jan 04, Mr *b7c-4, b6-4* Detainee Number
b7c-4, b6-4 Baghdad Central Confinement Facility, Abu Ghraib, IZ (BCCF), alleged Mr *b7c-4, b6-4*
forcibly sodomized Master *b7c-4, b6-4* while Master *b7c-4, b6-4* was detained at BCCF.

Investigation did not develop sufficient evidence to prove or disprove Mr *b7c-4, b6-4* allegation that
he observed Mr *b7c-4, b6-4* forcibly sodomize Master *b7c-4, b6-4* while an unidentified female soldier
exposed photographs of the incident. Master *b7c-4, b6-4* and Mr *b7c-4, b6-4* were both released from
custody prior to the initiation of this investigation and efforts to locate them were unsuccessful.
The delay in the initiation of this investigation negated the potential value of any physical
evidence. Investigation did not diminish the integrity or credibility of Mr *b7c-4, b6-4* allegation.

About 1000, 28 May 04, an administrative review of Report of Investigation (ROI) 0003-04-CID149-83130, determined that on 18 Jan 04, Mr. [REDACTED], Detainee Number [REDACTED] Baghdad Central Confinement Facility, Abu Ghriab, IZ (BCCF), alleged Mr. [REDACTED] b7c-4, b6-4 forcibly sodomized an unknown juvenile detainee at BCCF.

About 2150, 28 May 04, SA [REDACTED] b7c-1, b6-1 coordinated with SA [REDACTED] b7c-1, b6-1, b2 Prisoner Interview and Interrogation Team (PIT), BCCF, who stated he conducted a search of the records maintained at BCCF, which disclosed the victim for this investigation was Master [REDACTED] b7c-4, b6-4 (Tribal Name: [REDACTED], Internment Serial Number (ISN) [REDACTED]. Master [REDACTED] b7c-4, b6-4 was detained on 15 Sep 03 for Simple Assault and was released to the Ministry of Justice (MOJ).

About 1200, 29 May 04, SA [REDACTED] b7c-1, b6-1 coordinated with SA [REDACTED] b7c-1, b6-1 Criminal Intelligence Coordinator (CIC), 22nd Military Police Battalion (CID), Baghdad, IZ, who stated the 372nd Military Police Company conducted guard duty on Tier 1, BCCF, during the time frame of the incident.

About 1530, 31 May 04, SA [REDACTED] b7c-1, b6-1 reviewed the manning roster of the 372nd Military Police Company for the time frame of the incident. The review disclosed nine female personnel were assigned to the unit. (See Manning Roster for details)

About 0945, 2 Jun 04, SA [REDACTED] b7c-1, b6-1 conducted a search of the Combined Joint Special Operations Task Force-Arabian Peninsula (CJSOTF) Detainee Database, which disclosed no information which pertained to Master [REDACTED] or Mr. [REDACTED] b7c-4, b6-4

About 1100, 7 Jun 04, SA [REDACTED] b7c-1, b6-1 reviewed the Medical Screening Logs from 0003-04-CID149-83130, which disclosed Master [REDACTED] b7c-4, b6-4 was not treated by the medical personnel at BCCF between 1 Sep and 29 Oct 03.

About 1330, 7 Jun 04, SA [REDACTED] b7c-1, b6-1 reviewed the Joint Interrogation Debriefing Center (JIDC) Task Organization Chart, which disclosed no one named [REDACTED] was employed with the JIDC during the time frame of the incident. (See Task Organization Chart for details)

About 1425, 7 Jun 04, SA [REDACTED] b7c-1, b6-1 coordinated with Mr. [REDACTED] b7c-4, b6-4, Operations Manager, Titan Corporation, Baghdad, IZ, who stated Titan Corporation has never employed anyone named [REDACTED] b7c-4, b6-4 who worked at BCCF.

About 1630, 8 Jun 04, SA [REDACTED] b7c-1, b6-1 coordinated with COL [REDACTED] b7c-3, b6-3 MOJ, who stated detainees were not released to MOJ. [REDACTED] b7c-3, b6-3 stated MOJ maintained no

records of where detainees went after their release, as the capturing unit or detention facility maintained all documentation for the detainees. COL [REDACTED] stated he was unable to provide any information pertinent to this investigation. b7C-3, b6-3

About 1400, 12 Jun 04, SA [REDACTED] b7C-4, b6-4 coordinated with Mr [REDACTED] b7C-4, b6-4, Prisons Department, MOJ, who stated he conducted a search of his records for any information which pertained to Master [REDACTED] b7C-4, b6-4 and Mr [REDACTED] b7C-4, b6-4. Mr [REDACTED] b7C-4, b6-4 stated Master [REDACTED] b7C-4, b6-4 was no longer in the prison system. Mr [REDACTED] b7C-4, b6-4 further stated since Mr [REDACTED] b7C-4, b6-4 was apprehended under military operations, he did not enter into the control of MOJ.

About 1500, 22 Jun 04, SA [REDACTED] b7C-1, b6-1 received an electronic message from SA [REDACTED] b7C-1, b6-1, Assistant Operations Officer, 22nd Military Police Battalion, Baghdad, IZ, which reflected a review of this investigation and ROI 0003-04-CID149-83130 by the United States Army Criminal Investigation Command, 6010 6th Street, Fort Belvoir, VA, (USACIDC) revealed that the name [REDACTED] b7C-4, b6-4 was an alias of Mr [REDACTED] b7C-4, b6-4, Titan Corporation, Fairfax, VA.

About 1510, 28 Jun 04, SA [REDACTED] b7C-1, b6-1 briefed CPT [REDACTED] b7C-3, b6-3, Trial Counsel, III Corps Office of the Staff Judge Advocate, Baghdad, IZ, on all aspects of this investigation. TRANSLATION OF STATEMENT PROVIDED BY [REDACTED] b7C-4, b6-4 Detainee

"In the name of God, I swear to God that everything I witnessed everything I am talking about, I am not saying this to gain any material thing, and I was not pressured to do this by any forces. First, I am going to talk only about what happened to me in Abu Ghraib Jail. I will not talk about what happened when I was in jail before, because they did not ask me about that, but it was very bad

1. They stripped me of all my clothes, even my underwear. They gave me woman's underwear, that was rose color with flowers in it and they put the bag over my face. One of them whispered in my ear, "today I am going to fuck you", and he said this in Arabic. Whoever was with me experienced the same thing. That's what the American soldiers did, and they had a translator with them, named [REDACTED] b7C-4, b6-4 and a female soldier, who's skin was olive colored and this was on October 3 or 4, 2003 around 3 or 4 in the afternoon. When they took me to the cell, the translator [REDACTED] b7C-4, b6-4 came with an American soldier and his rank was sergeant (I believe). And he called told me "faggot" because I was wearing the woman's underwear, and my answer was "no". Then he told me "why are you wearing this underwear", then I told them "because you make me wear it". The transfer from Camp B to the Isolation was full of beatings, but the bags were over our heads, so we couldn't see their faces. And they forced me to wear this underwear all the time, for 51 days. And most of the days I was wearing nothing else.

2. I faced more harsh punishment from [REDACTED] b7C-4, b6-4. He cuffed my hands with irons behind my back to the metal of the window, to the point my feet were off the ground and I was hanging there, for about 5 hours just because I asked about the time, because I wanted to pray. And then they took all my clothes and he took the female underwear and he put it over my head. After he released me from the window, he tied me to my bed until before dawn. He took me to the shower room. After he took me to the shower room, he brought me to my room again. He prohibited me from eating food that night, even though I was fasting that day. [REDACTED] b7C-4, b6-4 and the other two soldiers were taking pictures of every thing they did to me. I don't know if they took a picture of me because they beat me so bad I lost consciousness after an hour or so.

3. They didn't give us food for a whole day and a night, while we were fasting for Ramadan. And the food was only one package of emergency food.

Now I am talking about what I saw:

1. They brought three prisoners completely naked and they tied them together with cuffs and they stuck one to another. I saw the American soldiers hitting them with a football and they were taking pictures. I saw [REDACTED] b7C-4, b6-4 punching one of the prisoners right in his face very hard when he refused to take off his underwear and I heard them begging for help. And also the American soldiers told to do like homosexuals (fucking). And there was one of the American soldiers they called Sergeant (black skin) there was 7 to 8 soldiers there also. Also female soldiers were taking pictures and that was in the first day.

of Ramadan. And they repeated the same thing the second day of Ramadan. And they were ordering them to crawl while they were cuffed together naked

2. I saw the translator [REDACTED] fucking a kid. his age would be about 15 - 18 years.

The kid was hurting very bad and they covered all the doors with sheets. Then when I [REDACTED] b7C-5, b6-5

heard the screaming I climbed the door because on top it wasn't covered and I saw [REDACTED] b7C-5, b6-5 who was wearing the military uniform putting his dick in the little kid's ass. I couldn't see the face of the kid because his face wasn't in front of the door. And the female soldier was taking pictures. [REDACTED] b7C-5, b6-5 I think he is Egyptian because of his accent, and he was not skinny or short, and he acted like a homosexual (gay). And that was in cell #23 as best as I remember.

3. In the cell that is almost under it, on the North side, and I was right across from it on the other side. They put the sheets again on the doors. [REDACTED] and his helper they cuffed one prisoner in Room #1, named [REDACTED] b7C-4, b6-4 he was Iraqi citizen. They tied him to the bed and they were inserted the phosphoric light in his ass and he was yelling for God's help. [REDACTED] b7C-4, b6-4 used to get hit and punished a lot because I heard him screaming and they prohibited us from standing near the door when they do that. That was Ramadan, around 12 midnight approximately when I saw them putting the stick in his ass. The female soldier was taking pictures.

4. I saw more than once men standing on a water bucket that was upside down and they were totally naked. And carrying chairs over their heads standing under the fan of the hallway behind the wooden partition and also in the shower.

Not one night for all the time I was there passed without me seeing, hearing or feeling what was happening to me

And I am repeating the oath / I swear on Allah almighty on the truth of what I said. Allah is my witness."

DETAILS

BASIS FOR INVESTIGATION: On 30 May 04, this office received a Category I Request For Assistance (RFA) (0132-04-CID259-80198) from the 78th Military Police (MP) Detachment (DET) (CID), Baghdad International Airport (BIAP), Baghdad, Iraq, which requested information pertaining to possible abuse of Detainee [REDACTED] National Detainee Reporting System (NDRS) number [REDACTED] and Detainee [REDACTED] National Identification Number [REDACTED] b7c-4, b6-4

At 0800, 31 May 04, SA [REDACTED] b7c-4, b6-1 coordinated with SPC [REDACTED] b7c-3, b6-3 Magistrates Cell, Baghdad Central Confinement Facility (BCCF), Baghdad, Iraq to obtain the prison records of Detainee [REDACTED] and [REDACTED] b7c-4, b6-1. The record of Detainee [REDACTED] was currently at Combined Joint Task Force-7 (CJTF-7). There was no record on file for Detainee [REDACTED] b7c-4, b6-1 as he was an Iraqi criminal.

At 0830, 31 May 04, SA [REDACTED] b7c-4, b6-1 coordinated with MSG [REDACTED] b7c-3, b6-3, Joint Interrogation and Debriefing Center (JIDC), BCCF, Baghdad, Iraq. MSG [REDACTED] provided the related interrogation reports for Detainee [REDACTED] b7c-4, b6-1 (See reports for details). MSG [REDACTED] stated there were no interrogation reports for Detainee [REDACTED] as he was never on Military Intelligence (MI) hold.

At 0900, 31 May 04, SA [REDACTED] b7c-4, b6-1 coordinated with MSG [REDACTED] b7c-3, b6-3 who provided a copy of the JIDC Task Organization chart, which listed the civilian interpreters MI utilized for their interrogations (See JIDC task organization chart for details).

AGENTS COMMENT: Unable to locate a list of prison guards on duty during the day shift for the requested time frame. The night shift prison guards; CPL Charles A. GRANER, [REDACTED] b7c-3, b6-3, Ivan L. FREDERICK, [REDACTED] b7c-3, b6-3; SPC Megan M. AMBUHL, [REDACTED] b7c-3, b6-3; SGT Javal S. DAVIS, [REDACTED] b7c-3, b6-3 and SPC Sabrina D. HARMAN, [REDACTED] b7c-3, b6-3, all members of 372nd MP CO, are all currently subjects in Report of Investigation (ROI) (0003-04-CID149-83130). The records this unit kept were very poor.

AGENTS COMMENT: Canvass interviews were not conducted due to the extremely poor record keeping of the previous unit, unable to determine who was in the Hard-site during the time in question and due to the fact that almost 1500 Detainees have been released in the past weeks.

AGENTS COMMENT: Unable to locate any kind of listing for juvenile detainees assigned to cells 20-25. A check of the Bio-Automated Toolset (BATS) for juveniles related there were five juveniles assigned to Tier 1, none of which were the Detainee [REDACTED]. It was unknown which cell, only that they were juveniles. It was unknown if they were in Tier 1 during that time frame. Detainee [REDACTED] has been released from the BCCF.

Status: Your RFA has been completed in the attached enclosures. No further investigative activity is anticipated by this office

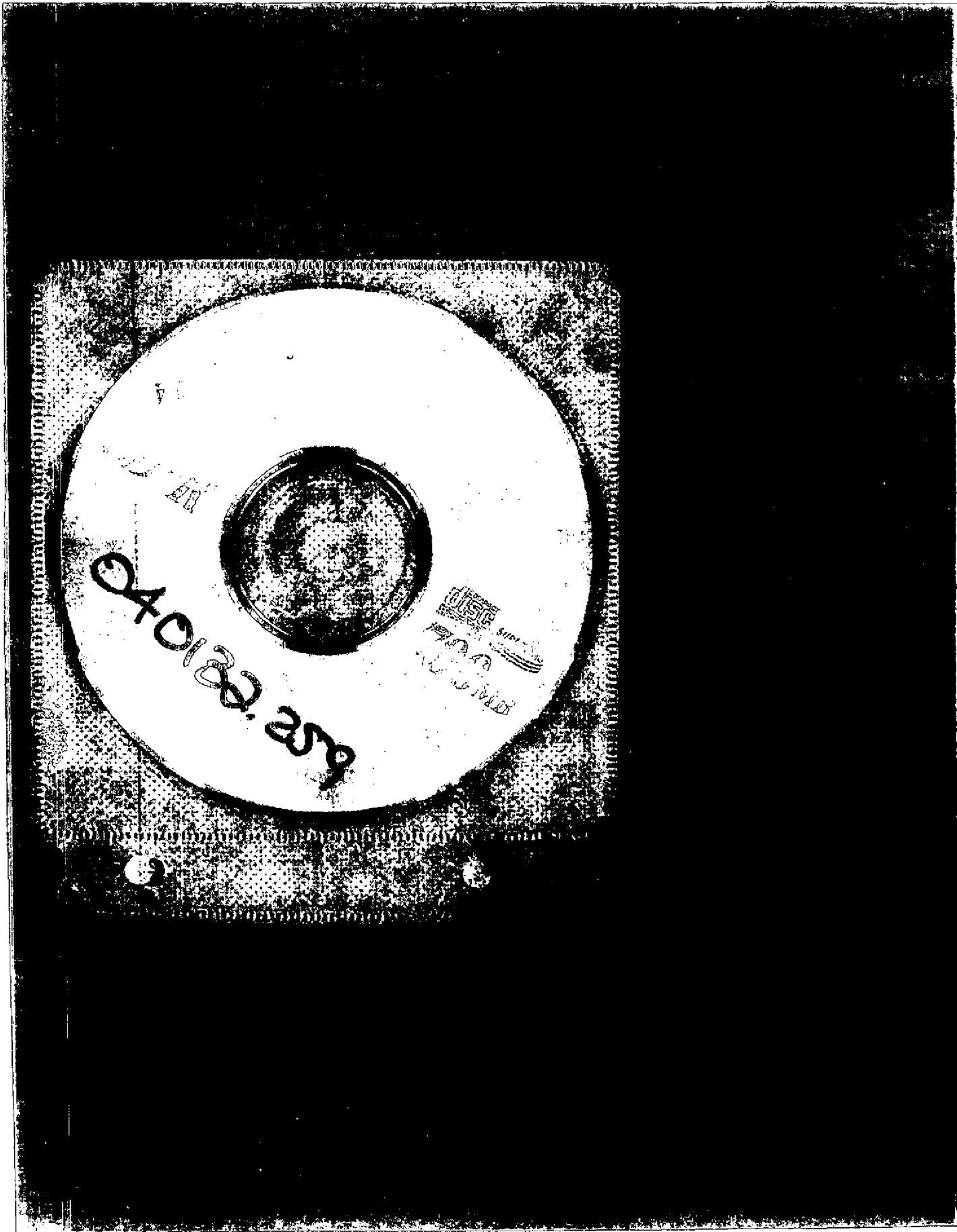

I check the dossiers on the individuals and determined each of them were 25+ yo. After checking with CPA, 391st MP BN, MI BN, and MAG Cell, I was unable to find a roster for the time period. As a last resort, I checked with inprocessing, who runs the BATS system, so they could query thier system for all juveniles that are and were here. I found the following individuals on the lists that were assigned to tier 1. It is unknown which cell and I only know that they are Juv. Also it is unknown if they were in Tier 1 during that time frame. The location seen on the list is the current or last location before release or transfer.

A. Maybe between 80 and 100 interviews.

A. MI and MP's, and some OGA.

Q. Have many times have you seen MI, MP, or OGA interrogate three detainees at the same time, handcuffed and nude, on the floor?

A. One time.

Q. Are you aware of the guidelines that are allowed by MI, MP and OGA when they are interviewing a detainee?

A. We were briefed on the guidelines. CPT [REDACTED] 67C-5,66-5 briefed us back in November sometime.

Q. Was this briefing prior to the incident mentioned above?

A. After this incident.

Q. Do you think that what the MPs and the MI were doing to the three detainees was a correct form of interrogation?

A. No. I think they took matters into their own hands.

Q. Why was it not the correct form of interrogations?

A. Well first of all they wanted to interview the detainees they should have let MI talk to them. I do not think

Q. So you realize this was an unauthorized interrogation?

A. Yes, I did not know if it was authorized or not.

Q. Did any of the men the detainees in this incident speak English?

A. No.

Q. Were you the only translator at this incident?

A. Yes. I even apologized to the detainees after this was down. I told them I thought what had happened was very degrading.

Q. What specifically did you tell the detainees to do?

A. Don't try to run away, stop right there, are you gay, do you like what is happening to you, are you all gays, you must like that position. These were some of the questions or things that I told them.

Q. Did you realize at the time that you were saying these things to the detainees that it was wrong to tell them these things the soldiers wanted you to say?

A. I do realize it was wrong at that time to say these things.

Q. Why was it was wrong to say these thing to the detainees?

A. Because it was degrading to them.

Q. Why did you translate these things anyway?

A. I thought that was what I was required to do as a translator.

Q. Did you ever receive any briefing how detainees would be treated?

A. No.

Q. Were you ever told who you could report detainee abuse to?

A. No. The only thing that is logical is to report it to your boss or to the unit.

Q. Do you feel what you said to these detainees was wrong?
