



On the above date and time this writer (SSG was notified that a detainee #9550 (Baker Yassen Rashed Mahmed Al Hussen) from 2A-123 was carried out to the hallway by ICOs and was possibly not breathing. On initial observation it appeared that detainee was not breathing and was immediately sent to the BCDF Clinic. Prisoner was 670.4,66-4 immediately sent to the BCDF Clinic in which Iraqi Doctor working on shift began to evaluate and perform a few chest compressions. At 0546hrs $Drb^{+}c \cdot 4$, bc $\cdot 4$ declared that the detainee had expired and claimed it could have been a heart $b7c \cdot 4$, $b6 \cdot 4$ attack or something with his brain. Initial investigation from eyewitness detainee revealed that at approximately 0530hrs himself b7c.4, b6-4and detainee #9550 was praying in their cell 2A-123 and that detainee #9550 suddenly collapsed on the floor. Detainee **collapsed** that at no time did detainee #9550 brL-4, b6-4 complain of any pain during the morning or during prayer. Detainee mediately b7c-4, b6-4 and Wing ICO 107(-7, 66-7 notified ICO Wing Supervisor who immediately wrapped detainee #9550 670-7, 66-7 . . . in a blanket and was carried to the BCDF Clinic. Detainee #9550 was left at clinic for removal and possible further investigation.
