Interrogation Techniques

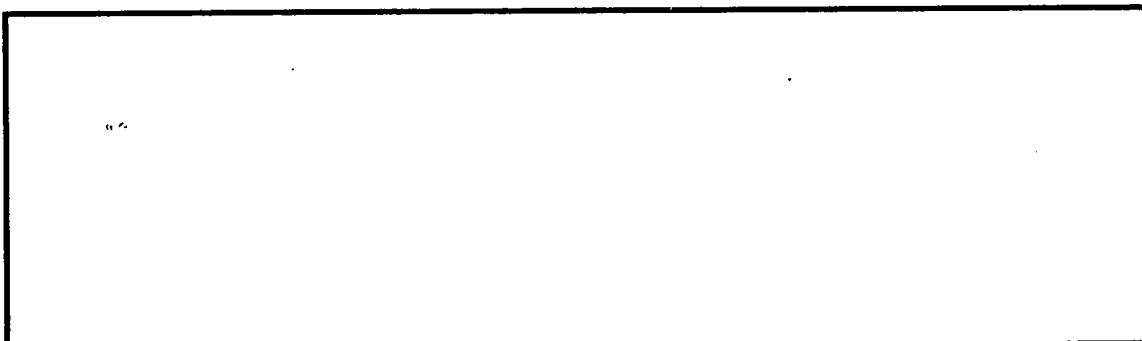
