(X) With regard to the transfer of prisoners from Sheberghan to Pol-I-Charki, Prosper was concerned about security and health issues long-term The lead nation for the reform of the Afghan Justice System is Italy Hence, Italy is supplying some resources to improve Pol-I-Charki Prosper felt additional money from the USA and other coalition partners would be needed to repair the prison system in Afghanistan

(SX Due to the length of time that the prisoners from Sheberghan had been held, and the fact that the FBI had already processed approximately 1,300 priscners from Sheberghan, Prosper did not anticipate the USG having any further intelligence interest in the prisoners at Pol-I-Charki.
