SHEBERGHAN IS LOCATED IN NORTHERN AFGHANISTAN. THE SHEBERGHAN PRISON COMPOUND CONTAINS APPROXIMATELY 1100 DETAINEES. THESE DETAINEES WERE LARGELY CAPTURED BY AFGHAN MILITARY FORCES, ASSISTED BY U.S. MILITARY FORCES, IN LATE 2001 NEAR THE CITY OF KONDUZ.

IN LATE 2002, THE FBI DEPLOYED A FIVE MEMBER TEAM TO SHEBERGHAN. THE TEAM SPENT APPROXIMATELY SIX WEEKS IN SHEBERGHAN AND OBTAINED THE FINGERPRINTS, PHOTOGRAPHS, DNA SAMPLES AND BIOGRAPHICAL INFORMATION OF EACH DETAINEE.


