As most of you probably expected, hearings are going to be starting up on the Hill regarding the Iraqi prisoner situation. AD Bald has been called to testify before closed session of the House Permanent Select Committee on Intelligence during the first week of June. The Committee is investigating "the policies regarding interrogations as part of the Global War on Terrorism, their legal basis, and what collection requirements have been levied on the interrogators."

The Committee has asked AD Bald to provide both written and oral testimony regarding "what information has been collected to date from the detainee interrogations, its relevance, timeliness, and accuracy, and what intelligence is currently being sought from detainees in the Global War on Terrorism." The Committee also wants AD Bald to "provide an estimate of what the loss to the Intelligence Community would be if the interrogation process were to end completely."

AD Bald has asked that ITOS I, ITOS II, MLDU, GTMO, and the Fly Team provide input into his testimony. This is a closed hearing so you will not have any restrictions on your (classified) responses. I will need these no later than COB 06/01/04 for AD Bald's review.
