Camp Delta, Guantanamo Bay, Cuba, by Special Agent [redacted] b7F -1
[redacted] Naval Criminal Investigative Service (NCIS). Also present
during the interview was Language Specialist [redacted]. The
interview was conducted in Arabic.

SA [redacted] report of this interview is incorporated b6 -2
herein: b7C -2

[redacted] complained about treatment he has received for his
leg injuries. He does not feel the Americans are giving him proper
treatment for his injuries. [redacted] denied going to fight jihad and
denied being a member of AL QAEDA. He went on to say that if he
admitted these things, he would be believed. Since he says he is b6 -3,4
not AL QAEDA, no one will believe him. [redacted] stated he is b7C -3,4
innocent. He went on to say that he has lied to interrogators in b7D -1
the past. When asked what he lied about, he stated he could not b7F -1
recall all the lies. He stated that as we talk, he will try to
remember his lies. [redacted] was asked why he lied. He stated that
he lied while in Bagram. He indicated he was in a lot of pain and
both his legs were severely injured. He was not treated well by
the guards and he was afraid if he told the truth, he would be
treated worse. He wanted to receive medical treatment and he was
afraid if he told the truth, the Americans would amputate his
leg(s). He went on to say that when he was captured he was not
armed; therefore, he cannot understand why he is in Cuba. He
stated if he wanted to be in a war, he would have stayed in

[REDACTED] He was asked why he had previously said he had been at the camp. [REDACTED] stated he started the lie at Bagram, while being interrogated. He indicated he was injured severely and in a lot of pain. His interrogators repeatedly asked him about the camp and if he had been there.

[REDACTED] stated he wanted to receive decent medical treatment and felt the only way to get it was to tell the Americans what they wanted to hear. [REDACTED] stated he was never at [REDACTED] and never trained at any camps in Afghanistan. [REDACTED] stated he would admit it if he had received training. He stated the only time he was in Kandahar was after the Americans detained him.
