The booth was quite crowded because there were several individuals present who were observing an "interview" in the room on the other side of the booth. In that room, the detainee was seated in a chair and was secured in the same method as I'd seen for all of the other detainees, shackled at his feet so that he could not leave the room. However, there wasn't much talking going on, because the lights had been turned off and a strobe light was flickering on and off, and loud rock music was being played. I estimate that this went on for 30 to 60 minutes. I was told by quite a few FBI personnel that tactics such as this were quite common there at the time. While there, I provided interview/interrogation advice to FBI SAs who were involved in ongoing interactions with detainees. I directly observed 14 interviews with 12 detainees. During one of these interviews (I am not sure which one at this time), I observed treatment of another detainee by a different interview team which included tactics that, while not overly aggressive, were clearly not consistent with Bureau interview policy/guidelines. To my knowledge, there were no FBI personnel involved in that interview. I do not recall at this time the identities or agency affiliations of those who were involved in that interview.
