Should [redacted] return to [redacted] he intends to marry. [redacted] does not intend to venture out of [redacted] for any other military training.

[redacted] clarified information he erroneously provided to interviewers in Bagram, Afghanistan. [redacted] explained that prior to an interview in Bagram, he was forced to strip naked in front of others. This process was distressing to [redacted] who inadvertently advised his interviewers that he had carried a weapon. [redacted] explained that during his initial interview his response actually referred to the weapons which he observed [redacted] said he did not carry a weapon [redacted] and does not recall seeing weapons [redacted] nor did [redacted] have a weapon when he was captured.
