SUBJECT: GTMO DETAINEE: URGENT DEMARCHE REQUEST

1. Background: Among the detainees from the conflict in
 Afghanistan being held by U.S. military authorities at
 Guantanamo Bay, Cuba (GTMO), is [REDACTED] B6
 who suffers from a serious mental illness. U.S. authorities
 and [REDACTED] are strongly of the view -- B1
 shared by USG and [REDACTED] that [REDACTED] B6
 must be repatriated to [REDACTED] for long-term care
 immediately. In a meeting with [REDACTED] B1
 [REDACTED] last week, DoD Office of General Counsel advised
 of the urgency of [REDACTED] finding a place for the detainee
 in [REDACTED] with which [REDACTED] expressed agreement.
 [REDACTED] however, is reluctant to arrange such placement B1
 [REDACTED] It is clear that the senior
 levels of the [REDACTED] must be engaged on this issue in order to

ensure that [] arranges a facility for [] so
that he can be repatriated to [] not later than the
end of this month.

2. Action request: Department requests that [] contact
[] at his earliest opportunity
Tuesday, April 16, in order to convey the following points:

-- You may be aware of an extremely serious case of mental
illness suffered by one of the detainees from the conflict in
Afghanistan who is now in U.S. control at the U.S. Naval
Station in Guantanamo Bay, Cuba.

-- Continued detention by U.S. military authorities is
untenable. Most importantly, it is the view of U.S.
authorities and [] in Guantanamo that, for his
own sake, the detainee must be repatriated to [] on
an immediate basis.

-- We have enjoyed an excellent working relationship with
[] we have been
particularly gratified by their commitment to arranging an
acceptable place for the detainee in [] most
recently expressed by [] in his meeting with
Pentagon officials last week.

-- We understand, however, that [] has not yet
arranged such a placement for the detainee.

-- We need your assistance in ensuring that such a placement
is in fact arranged expeditiously so that the detainee can be
transferred -- as we intend to do -- by the end of this month.

[] assistance on this matter is crucial on
humanitarian grounds. It is the considered opinion of
medical experts that the detainee needs long-term care in his
home country.
