(S) Embassy offers the following updated information in response to refTel on status of [redacted] detainees at GTMO:

Regarding the two detainees at GTMO that have been approved for release to [redacted]

[redacted] the [redacted] is prepared to have the two return to [redacted] on the next airbridge out of GTMO and requests an update on proposed timing of their return. Note: based on the information contained in ref a, we told [redacted] the next airbridge would probably be in September. (d note.) [redacted]

The [redacted] reminded us that family members and other interested parties in [redacted] continue to press the [redacted] to ensure that the detainees are returned to [redacted] as soon as possible.
