

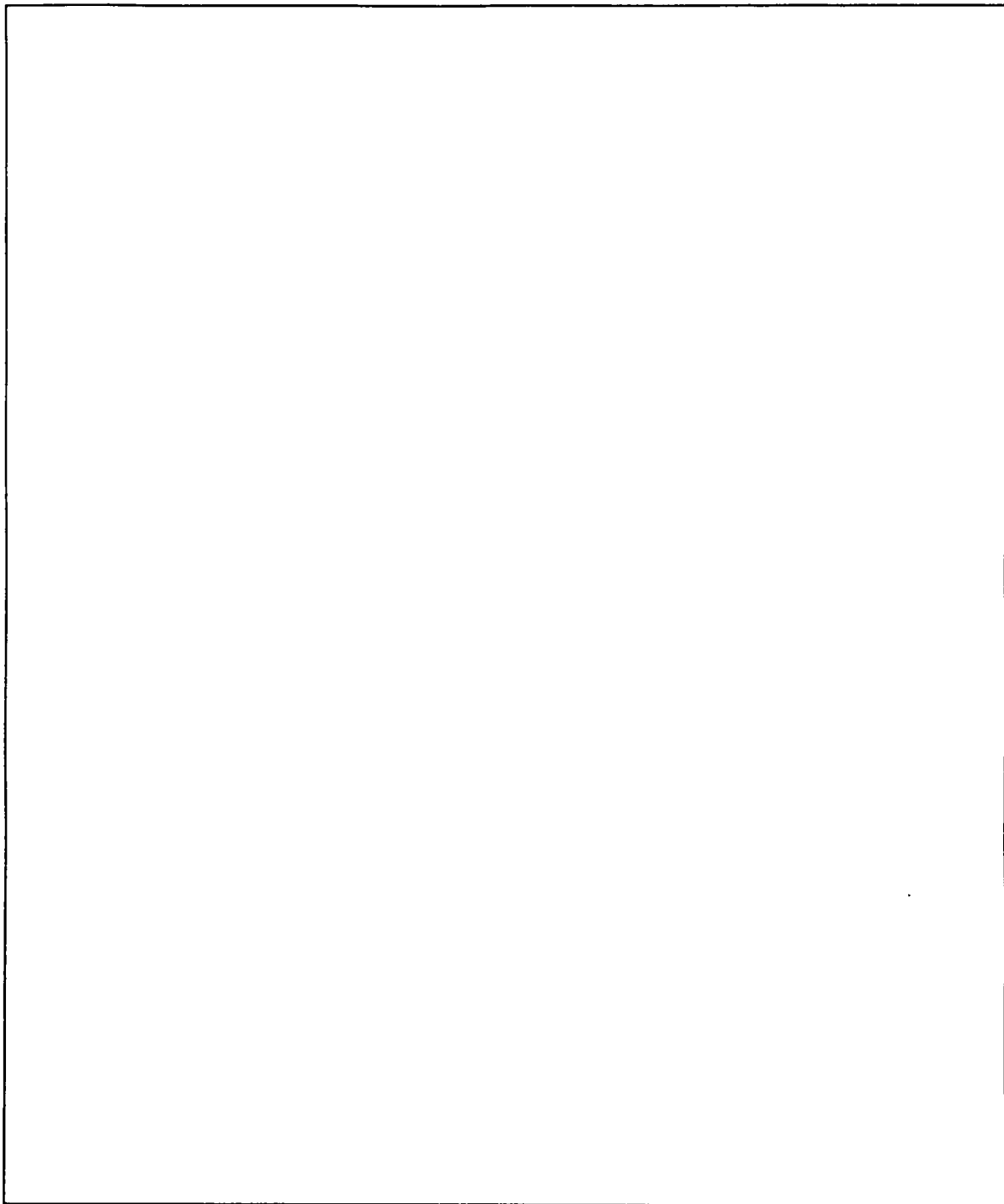
. Posts are requested to use points in paragraph 6 to approach the above-named governments regarding the transfer of these individuals, confirm that the host governments are willing to accept their
