1. SUMMARY: IN OFFICIAL OR INFORMAL DISCUSSIONS OF THE STATUS OF THESE ISSUES POST SHOULD ORAW ON THE POINTS CONTAINED IN PARA 3. THE ISSUES RELATING TO USG ACTIONS IN THE WAKE OF SEPTEMBER 11 ARE EVOLVING QUICKLY AND ARE THE SUBJECT OF INTENSIVE INTER-AGENCY DELIBERATION AT THIS TIME. WE MUST REASSURE THE OSCE THAT WE ARE ATTENTIVE TO ITS NEED FOR RESPONSES, BUT IT IS CRUCIAL THAT THE USG RESPONSE BE AS DEFINITIVE AS THE SITUATION WILL ALLOW AT THIS TIME. WE MUST ASK THE OSCE AND OUR FELLOW PARTICIPATING STATES FOR PATIENCE. WHEN WE HAVE RESPONSES TO THE SPECIFIC QUESTIONS THAT ARE BEING RAISED. INCLUDING THE STATUS OF MILITARY VERSUS CIVILIAN TRIBUNALS AND THE STATUS OF ALGERIAN OETAINEES, WE WILL PROVIDE POSTS WITH THAT INFORMATION. END SUMMARY.

2. THE USG IS SEIZED WITH THIS ISSUE. WE ARE COGNIZANT OF OUR RESPONSIBILITIES AS AN OSCE MEMBER TO RESPOND TO THE SERIOUS QUESTIONS POSED TO US. WE FEEL OUR ACTIONS AND OUR PLANS ARE CONSISTENT WITH THE USG'S COMMITMENT TO

RESPECT AND SAFEGUARD INTERNATIONAL LAW. THE USG WELCOMES THE OPPORTUNITY TO ADORESS THESE ISSUES WITH ITS PARTNERS, AND WE WILL KEEP THE PC INFORMEO AS THIS ISSUE OEVELOPS. AT THE SAME TIME, WE MUST ASK THE OSCE AND OUR FELLOW PARTICIPATING STATES FOR PATIENCE. WHEN WE HAVE RESPONSES TO THE SPECIFIC QUESTIONS THAT ARE BEING RAISED, WE WILL CONTACT YOU WITH THAT INFORMATION.

3. POST IS AUTHORIZED TO DRAW FROM THE FOLLOWING POINTS IN RESPONDING TO QUESTIONS RAISED IN RELATION TO OFTENTIONS AT GUANTANAMO:

--THE LEGAL STATUS OF OETAINEES IS CURRENTLY BEING REVIEWED WITHIN THE ADMINISTRATION.

--WHATEVER THE LEGAL STATUS OF OETAINEES, THE INDIVIOUALS BEING OETAINEO AT GUANTANAMO ARE BEING TREATED HUMANELY CONSISTENT WITH THE PRINCIPLES OF THE GENEVA CONVENTIONS.

-- EACH DAY THE DETAINEES ARE GIVEN THREE CULTURALLY APPROPRIATE MEALS.

--IT IS OF COURSE THE CASE THAT THESE OETAINEES ARE VERY DANGEROUS PEOPLE, AND ALL APPROPRIATE SECURITY PRECAUTIONS ARE BEING TAKEN.

--WE ARE CONTINUING TO INVESTIGATE THE CONNECTION BETWEEN THE DETAINEES AND AL QAEDA, AND ARE COLLECTION ANY RELEVANT INFORMATION CONCERNING CRIMES THAT MAY HAVE COMMITTEO.

--THE INTERNATIONAL COMMITTEE FOR THE RED CROSS IS BEING GIVEN ACCESS TO THE DETAINEES AT GUANTANAMO TO INSPECT THE
