

1. (U) This is an action message.

2. (C) Addressee posts [REDACTED] are requested to inform host governments at the earliest opportunity of information related to the transfer of their national(s) [REDACTED] to U.S. facilities in Guantanamo Bay. Personal information on detainees in paragraph 5 may be shared with host government. We will provide further identifying details on detainees that could be shared with host governments as it becomes available. Please do not share details on nationals from third countries with host government. Post, and host government, should be aware that much of this information is self-reported by the detainee. It may be inaccurate and even intended to deceive.


