1. SUMMARY: THE SWISS NATIONAL COUNCIL (LOWER HOUSE OF
PARLIAMENT) ADOPTED MARCH 6 A DECLARATION CALLING ON ALL
STATES TO RESPECT THE GENEVA CONVENTIONS, PARTICULARLY IN
TODAY'S FIGHT AGAINST TERRORISM. ALTHOUGH PROMPTED BY THE
UNCLASSIFIED

RECENT CONTROVERSY OVER THE TREATMENT OF TALIBAN AND AL
QAIDA DETAINEES, THE DECLARATION STOPPED SHORT OF
CRITICIZING THE UNITED STATES FOR ITS TREATMENT OF DETAINEES
IN GUANTANAMO BAY. FOMIN JOSEPH DEISS WELCOMED THE
DECLARATION, ASSERTING THAT INTERNATIONAL HUMANITARIAN LAW
MAY NOT BE QUALIFIED IN THE NAME OF FIGHTING TERRORISM. THE
NATIONAL COUNCIL'S FOREIGN POLICY COMMITTEE IS PREPARING A
GENERAL DECLARATION ON THE GENEVA CONVENTIONS ON JUNE 8 ON
THE OCCASION OF THE 25TH ANNIVERSARY OF THE ADOPTION OF THE
CONVENTIONS' TWO ADDITIONAL PROTOCOLS.

2. THE DECLARATION ADOPTED BY THE NATIONAL COUNCIL MARCH 6 CALLED ON ALL STATES TO RESPECT THE GENEVA CONVENTIONS AND ASSERTED THAT THE CONVENTIONS SET INDISPUTABLE MINIMUM STANDARDS THAT MAY NOT BE QUALIFIED UNDER ANY CIRCUMSTANCES, INCLUDING IN THE FIGHT AGAINST TERRORISM. THE DECLARATION STATES THAT TERRORISM CONSTITUTES A CRASS VIOLATION OF UNIVERSAL HUMANITARIAN VALUES, BUT ALSO EMPHASIZES THAT TERRORISM MUST BE FOUGHT ON THE BASIS OF THESE UNIVERSAL PRINCIPLES SET FORTH IN THE CONVENTIONS AND WITHOUT VIOLATING INTERNATIONAL HUMANITARIAN LAW. THE NATIONAL COUNCIL SILENTLY ADOPTED THE DECLARATION BY TACIT APPROVAL OF ITS MEMBERS.

3. THE SPONSOR OF THE DECLARATION, THE SOCIALIST (SP) PARLIAMENTARIAN REMO GYSIN, ORIGINALLY WANTED TO CENSURE THE UNITED STATES FOR ITS TREATMENT OF TALIBAN AND AL QAIDA PRISONERS HELD AT GUANTANAMO. HOWEVER, THE NATIONAL COUNCIL'S FOREIGN AFFAIRS COMMITTEE DECIDED AGAINST EXPLICITLY MENTIONING THE UNITED STATES ON THE GROUNDS THAT

SUCH A DECLARATION WOULD HAVE HAD TO CENSURE OTHER COUNTRIES, TOO. THUS, THE DRAFT DECLARATION WAS MODIFIED TO CALL ON THE AUTHORITIES OF ALL COUNTRIES TO HONOR THE GENEVA CONVENTIONS. GYSIN DECLARED HIMSELF DISAPPOINTED THAT THE DECLARATION FALLS SHORT OF TARGETING THE UNITED STATES. "THE PROMOTION OF HUMAN RIGHTS IS A TENET OF SWITZERLAND'S FOREIGN POLICY AND WE HAVE TO INSIST ON THE RESPECT OF THESE RIGHTS EVEN IF THE COUNTRY IN QUESTION IS THE UNITED STATES," HE TOLD SWISS RADIO INTERNATIONAL.

4. FOREIGN MINISTER JOSEPH DEISS WELCOMED THE DECLARATION SAYING THAT UNDER PRESENT CIRCUMSTANCES IT WAS APPROPRIATE FOR SWITZERLAND, WITH ITS HUMANITARIAN TRADITION AND AS THE DEPOSITARY STATE OF THE GENEVA CONVENTIONS, TO RAISE ITS VOICE IN FAVOR OF COMPLETE AND UNCONDITIONAL RESPECT FOR INTERNATIONAL HUMANITARIAN LAW. DEISS SAID THAT HIS DEPARTMENT HAD EXAMINED THE DECLARATION AND FULLY ENDORSES BOTH ITS FORM AND CONTENT. BY ADDRESSING THE ENTIRE INTERNATIONAL COMMUNITY RATHER THAN EXPLICITLY MENTIONING A SPECIFIC COUNTRY, OPINED DEISS, THE DECLARATION SENDS A CLEAR BUT BALANCED HUMANITARIAN MESSAGE THAT REMINDS EACH COUNTRY OF ITS OBLIGATIONS NOT ONLY TO RESPECT THE GENEVA CONVENTIONS IN ALL CIRCUMSTANCES BUT ALSO, AS SWITZERLAND DOES, TO CALL ON OTHERS TO DO LIKEWISE.

5. THE NATIONAL COUNCIL'S FOREIGN POLICY COMMITTEE IS CURRENTLY PREPARING A GENERAL DECLARATION ON THE GENEVA

STATES TO RATIFY AND HONOR THE FOUR GENEVA CONVENTIONS AS
WELL AS ITS TWO ADDITIONAL PROTOCOLS. THE DRAFT TEXT
SPECIFICALLY INCLUDES A REFERENCE TO AN INTERNATIONAL FACT-
FINDING COMMISSION AS SPECIFIED IN ARTICLE 90 OF THE FIRST
ADDITIONAL PROTOCOL. THE FOREIGN POLICY COMMITTEE IS
SCHEDULED TO DEBATE THE DRAFT DECLARATION AT ITS NEXT
MEETING AT THE END OF APRIL. IT REMAINS TO BE SEEN WHETHER
THE COUNCIL OF STATES (UPPER HOUSE) WILL ISSUE A SIMILAR
DECLARATION. DECLARATIONS BY THE SWISS PARLIAMENT AS SUCH
ARE RATHER UNUSUAL. THE LAST TIME THE SWISS PARLIAMENT
RESORTED TO THIS MECHANISM WAS DURING THE GULF WAR.
