THE MFA SPOKESMAN SAID THE GOB HAS INSISTED "... ON ASCERTAINING WHETHER ANY BAHRAINIS ARE BEING HELD AND ENSURING THAT THEY ARE TREATED HUMANELY IN KEEPING WITH THE GENEVA CONVENTION." THE SPOKESMAN ADDED THAT THE GOB WANTS ANY BAHRAINI DETAINEES TO BE HANDED OVER TO IT "SO THEY ARE DEALT WITH IN ACCORDANCE WITH THE LAW."

- 3.(U) ON JANUARY 25, LOCAL NEWSPAPERS PUBLISHED A STATEMENT FROM THE BAHRAIN HUMAN RIGHTS SOCIETY (BHRS) THAT EXPRESSED CONCERN ABOUT THE REPORTS AND PHOTOGRAPHS OF COMBATANTS CAPTURED IN AFGHANISTAN AND "SHIPPED" TO GUANTANAMO BAY. THE BHRS STATEMENT SAID "THAT THE CAPTURED AFGHANS WERE "HELD HOODED AND BLINDFOLDED IN SMALL CAGES AND IN INHUMANE. CONDITIONS." BHRS EXPRESSED ITS CONCERNS ABOUT SECRETARY OF DEFENSE RUMSFELD'S STATEMENT THAT THE PRISONERS WERE UNLAWFUL COMBATANTS NOT ENTITLED TO THE PROTECTION UNDER THE GENEVA CONVENTIONS ON THE TREATMENT OF PRISONERS OF WAR. BHRS STATEMENT ASSERTED THAT THE DETAINEES ARE PRISONERS OF WAR. CLAIMED THAT USG TREATMENT OF THE PRISONERS VIOLATED THEIR HUMAN RIGHTS, AND CALLED ON THE USG TO RESPECT INTERNATIONAL LAW PROHIBITING THE TORTURE AND INHUMANE TREATMENT OF PRISONERS OF WAR. THE STATEMENT INSISTED THAT THE USG PROVIDE THE DETAINEES WITH ADEQUATE SHELTER AND MEDICAL FACILITIES.
- 4.(U) LOCAL ARABIC PAPERS ON JANUARY 27 AND 28 CARRIED COMMENTARIES CRITICIZING USG TREATMENT OF PRISONERS HELD AT GUANTANAMO BAY. ONE COLUMNIST "CRITICIZED THE PIONEER COUNTRY IN PROTECTING HUMAN RIGHTS FOR BECOMING A VICIOUS MONSTER ..." HE ADDED THAT THE PRISONERS' MISTAKE OF GOING TO AFGHANISTAN TO FIGHT DID NOT MERIT THE PUNISHMENT AND TORTURE AMERICA IS IMPOSING ON THEM.

DETAINEES (WHILE NOTING THAT THE MFA WAS SLOW IN DOING SO) AND URGED THE GOB TO INSIST THAT ANY BAHRAINIS BE RETURNED TO BAHRAINI AUTHORITIES TO ENSURE THE DETAINEES ARE TREATED LIKE HUMAN BEINGS. THE COLUMNIST ADDED THAT MANY OF THE GUANTANAMO DETAINEES WERE MISLED YOUNGSTERS, RATHER THAN HARDENED CRIMINALS.
