- -- AS LONG AS HOSTILITIES CONTINUE, THE USG MUST-AS A MATTER OF NATIONAL SECURITY, MILITARY NECESSITY, AND COMMON SENSE-CONTINUE TO DETAIN ENEMY COMBATANTS WHO COULD REJOIN THE FIGHT AGAINST US IF PROVIDED THE OPPORTUNITY.

- --WE HAVE NOW RECEIVED IN WASHINGTON A DIPLOMATIC NOTE FROM YOUR EMBASSY FORMALLY REQUESTING ANOTHER VISIT TO GUANTANAMO. AS YOU MAY RECALL, GOVERNMENT REQUESTS TO VISIT THE US NAVAL BASE GUANTANAMO WILL BE GRANTED ONLY FOR LAW ENFORCEMENT OR INTELLIGENCE COLLECTION PURPOSES, SUBJECT TO THE SAME PROCEDURES AND CONDITIONS THAT APPLIED FOR YOUR GOVERNMENT'S VISIT FEBRUARY.
